VIII. MATTERS REQUIRING REFERRAL TO OGC/ADRO:

A. OGC –

Failure to Provide Supporting Schedules (Standard 7)

The Committee can be referred to the Office of General Counsel (OGC) for disclosing \$1,603,950.00 in transfers received from two (2) joint fundraisers, but only \$739,370.43 in memo receipts itemizing its share of the gross contributions received through the joint fundraisers during the 2016 calendar year, a discrepancy of \$864,579.57.

B. ADRO –

Mathematical Discrepancies (Standard 6)

The Committee can be referred to the Alternative Dispute Resolution Office (ADRO) on the 2015 March Monthly Report for an opening cash-on-hand discrepancy totaling \$39,875.39.

The Committee be referred to ADRO on the 2015 April Monthly Report for an opening cash-on-hand discrepancy totaling \$39,875.39.

Failure to Provide Supporting Schedules (Standard 7)

The Committee can be referred to ADRO on the 2016 August Monthly Report for disclosing four (4) debts owed by the Committee with outstanding beginning balances that were not disclosed with outstanding ending balances on the prior report, resulting in a missing schedule of \$40,733.50.

The Committee can be referred to ADRO on the 2016 September Monthly Report for failing to continuously report seven (7) debts owed by the Committee, totaling \$42,238.13 previously disclosed on Schedule D.
