**Re: Violation the Federal Election Campaign Act of 1971**

Thank you for your letter reminding us that we may have violated the above Act. Specifically, we may have donated money directly or indirectly to the campaigns of Ralph Torres (who was running for Lt. Governor in 2014) and Angel Damapan (who was running for CNMI House Representative in 2014) from the 2014 election.

According to our records, we did make our contribution of US\$5,000 to the dinner party, as requested by Mr. James a. Ada in 2016, to show our support to continue the policy of a strong Private and Public Partnership. (The letter for this event is attached for your reference). We also made a contribution of US\$5,000 in 2017, as requested by a group made up of family and friends, to sponsor a 38<sup>th</sup> birthday dinner party for honorable Ralph DLG. Torres. (The letter is also attached for your reference).

We had donated US\$2,100 for Mr. Angel Damapan in January 2015, as requested by Mr. Angel Demapan after he won the election. (The letter is also attached for your reference). In addition, we bought 5 fundraising dinner party tickets @US\$100 each for Angel Demapan for Congress in August 2016.

We, HPIL limited did not aware of our participation in the above social events may have violated the Federal Election Campaign Act of 1971. We are pleased to co-operate with your office and hope the above would help you to consider our position in this matter.


