1. Open a Matter Under Review with respect to Pre-MUR 609

2. Find reason to believe that Ralph G. Torres and the Ralph G. Torres Campaign violated 52 U.S.C. § 30121(a)(2) by accepting foreign national contributions.

3. Find reason to believe that Angel A. Demapan and Angel Demapan for House violated 52 U.S.C. § 30121(a)(2) by accepting foreign national contributions.

4. Find reason to believe that Imperial Pacific International Holdings, Alter City Group Holdings Limited, Honest Profit International Limited, and Hong Kong Entertainment violated 52 U.S.C. § 30121(a)(1)(A) by making foreign national contributions.

5. Find reason to believe that Friends of Ralph violated 52 U.S.C. § 30121(a)(1)(A) and 11 C.F.R. § 110.20(h) by accepting foreign national donations in connection with a federal election.

6. Find no reason to believe that Demapan for Congress and Geralyn C. DelaCruz in her official capacity as treasurer violated 52 U.S.C. § 30121(a)(1)(A) by accepting foreign national contributions.
7. Dismiss the allegation that the Lady Diann Torres Foundation violated the Act.
8. Approve the Factual and Legal Analyses, as recommended in the First General Counsel's Report dated May 23, 2019, and last circulated by Chair Weintraub's Office on July 25, 2019. [REDACTED]

9. Enter into conciliation with Ralph G. Torres and the Ralph G. Torres Campaign, Angel A. 10. Approve the conciliation agreements, as recommended in the First General Counsel's Report dated May 23, 2019. [REDACTED]


11. Approve the appropriate letters.
