  - a. Dismiss the allegation that Susan B. Anthony List Inc. Candidate Fund and Jennifer Gross in her official capacity as treasurer violated 52 U.S.C. §§ 30104(b) and 30118(a) and issue a letter of caution.
  - b. Dismiss the allegation that The Lukens Company violated 52 U.S.C. § 30118(a) and issue a letter of caution.
  - c. Find no reason to believe that Robert J. Kania II violated the Act.
  - d. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated February 20, 2020.
  - e. Approve the appropriate letters.
  - f. Close the file.

- b. Dismiss the allegation that The Lukens Company violated 52 U.S.C. § 30118(a) and issue a letter of caution.
- c. Find no reason to believe that Robert J. Kania II violated the Act.
- d. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated February 20, 2020, subject to the edits circulated by Commissioner Cooksey's Office on November 8, 2021 at 12:45 p.m.
- e. Approve the appropriate letters.
- f. Close the file.

Commissioners Cooksey, Dickerson, and Trainor voted affirmatively for the motion.

Commissioners Broussard and Weintraub dissented. Commissioner Walther abstained.

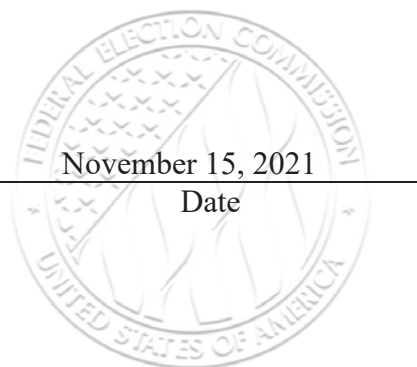
3. Decided by a voted of 6-0 to:
