Dear Ms. Ross,

The Commission should dismiss the complaint against Friends of Christine O'Donnell ("FOCD") and Christopher M. Marston, in his official capacity as treasurer,¹ because the matter is now moot.

The complainant alleges that Ms. O'Donnell and FOCD are "attempting to convert campaign committee assets... to personal use." MUR 7640, Complaint at 1. In support of this allegation, the complaint cites the petition for accounting filed by Ms. O'Donnell in the Circuit Court for Loudon County alleging that Allegiance List Marketing, LLC, may have acted illegally or unethically in connection with a mailing list that Ms. O'Donnell claimed to have an ownership interest in.

However, on October 28, 2019, Ms. O'Donnell, by and through counsel, exercised her right pursuant to section 8.01-380 of the Virginia Code to nonsuit the action.² A nonsuit is a procedural right to voluntarily dismiss a case. So, in other words, Ms. O'Donnell voluntarily withdrew the petition for accounting upon which the complaint in this matter is wholly based.

Absent the existence of the Virginia state court proceedings between Ms. O'Donnell and Allegiance List Marketing, LLC, the complaint in this matter is moot. As such, the Commission should dismiss the allegations in the complaint that FOCD and Christopher Marston, in his official capacity as treasurer, violated the Federal Election Campaign Act of 1971, as amended (the "Act").
