This complaint is made by me as an individual American citizen and taxpayer, against Senator Cory Gardner of Colorado, for accepting illegal campaign contributions from shell corporations in violation of the Federal Election Campaign Act of 1971.

Prior complaints have been lodged with the FEC about Gardner and illegal contributions.<sup>1, 2, 3</sup> Starboard Strategic, Inc. is a shell corporation for the National Rifle Association to funnel money into political campaigns. The NRA Political Victory Fund paid \$2.6 million to Starboard to support Gardner and work against opponents, and the NRA Institute for Legislative Action paid over half a million dollars to Starboard for the same thing. The FEC's own website shows the NRA and Gardner using shell corporations.<sup>4</sup>

The FEC has not taken any action to stop these illegal contributions despite evidence of wrongdoing since 2014. I request that the FEC:

- 1. Investigate the shell corporation Starboard Strategic, Inc. and its precursor OnMessage and stop them from funneling illegal contributions into our campaigns.
- 2. Monitor the NRA so it doesn't use new shell corporations to avoid spending limits.
- 3. Stop Senator Cory Gardner from accepting illegal campaign contributions.
- 4. Honor the fourth prong of the FEC mission, to wit: enforce the campaign finance laws through audits, investigations, and civil litigation.
