  - b. Dismiss with caution allegations that Jeff Coleman and Jeff Coleman for Congress, Inc. and Joseph Johnson in his official capacity as treasurer, violated 52 U.S.C. §§ 30116(f) and 30118 by accepting in-kind contributions.
  - c. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated August 14, 2020.
  - d. Approve the appropriate letters.
  - e. Close the file.

Commissioners Broussard, Walther, and Weintraub voted affirmatively for the motion.

Commissioners Cooksey, Dickerson, and Trainor dissented.

2. Failed by a vote of 3-3 to:

  - b. Dismiss allegations that Jeff Coleman and Jeff Coleman for Congress, Inc. and Joseph Johnson in his official capacity as treasurer, violated 52 U.S.C. §§ 30116(f) and 30118 by accepting in-kind contributions.
  - c. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated August 14, 2020, subject to the edits circulated by Commissioner Cooksey's Office on November 8, 2021 at 12:57 p.m. and further subject to the additional edit of removing the reference of cautionary letters on page 2, line 6, and footnote 43.
  - d. Approve the appropriate letters.
  - e. Close the file.

Commissioners Cooksey, Dickerson, and Trainor voted affirmatively for the motion.

Commissioners Broussard, Walther, and Weintraub dissented.
