Dear Mr. Jordan,

Please accept this reply on behalf of the Voices of the American Federation of Government Employees (Voices) to the allegations raised by "Major Mike" Webb in MUR 7691. The allegations further reference the National Active and Retired Federal Employees Association's Political Action Committee (NARFE-PAC) and Friends of Don Beyer. Voices has no connection to either group, nor any information as to the various allegations raised by Mr. Webb as they pertain to either NARFE-PAC or Friends of Don Beyer, except as to the allegation related to the alleged Voices contributions to Friends of Don Beyer.

We have checked our records, and can find no such donation being made from Voices to Friends of Don Beyer, although we do see that Friends of Don Beyer did make an FEC report for 2018 that indicates a \$5,000 receipt of funds on or about May 22, 2018. I have checked the FEC reports for the American Federation of Government Employees Political Action Committee (AFGE PAC) and found that AFGE PAC, not Voices, did report making a \$5,000 contribution to Friends of Don Beyer on or about May 11, 2018. I have further requested and had AFGE PAC produce a copy of the actual check in question, which is attached along with the relevant portions of the 2018 AFGE PAC FEC Report, Schedule B, Form 3X, Itemized Disbursements, at Page 140, and the 2018 Friends of Don Beyer FEC Report, Schedule A, Form 3, Itemized Receipts, at Page 89. There appears to be an improper coding error on the Friends of Don Beyer FEC Report attributing the AFGE PAC check to Voices.

We also checked the 2019 FEC reports for the AFGE PAC, which appear, similarly, to coincide with the amounts in receipt of Friends of Don Beyer for 2019, with the same coding error. At this time, I would request an extension of an additional 14 days to respond as to those reports and obtain a copy of the actual check from AFGE PAC. My understanding is that Counsel for Friends of Don Beyer is also requesting an extension of time, and this may be helpful to see where the coding error occurred, as it does not appear to have occurred as to AFGE PAC's FEC reporting of the contribution.

Thank you for your attention to this matter and appreciate your consideration for some additional time to obtain the actual check from the AFGE PAC account, as Voices is not in possession of an evidence of a 2018 or 2019 donation, but believes evidence does exist that would show the contribution properly came from AFGE PAC and was properly accepted by Friends of Don Beyer.
