To whom this may concern,

I am writing this in response to the complaint dated February 12, 2020 on behalf of Urbina for Congress. We ask that this matter continue to be strictly confidential as we have attached personal information to this email. We will be responding to this complaint pro se and will not be retaining counsel.

All charges included in this complaint are false, have no merit and are the result of retaliation for the dismissal of Bruce Leal from Urbina for Congress. Since his dismissal from Urbina for Congress, Mr. Leal has filed frivolous cases against Urbina for Congress and Ms. Urbina with the [National Labor Relations Board](#) and in the [Circuit Court for Prince George's County Maryland](#). He is also a defendant in a case brought by [Urbina for Congress in the Circuit Court for Prince George's County for tortious conduct](#) committed in an effort to sabotage my political campaign.

If it is found that Mr. Urbina, Briana Urbina or Urbina for Congress failed to comply with any regulation or statute, Urbina for Congress would graciously ask for an opportunity to amend all FEC filings to bring them into compliance with governing law. The committed never intended to commit any wrongdoing and we will take all necessary steps to remedy any errors we may have committed.

1. Urbina for Congress (UFC) did not violate any reporting requirements of the Federal Election Campaign Act or any regulations promulgated by the Federal Election Commission.
2. Mr. Leal was the treasurer of UFC for a brief time in 2019 but lacks the knowledge sufficient to substantiate any claim against UFC.
3. UFC amended filings eliminating debts owed by the committee as a result of Mr. Leal's tortious conduct. If these debts are required to be listed until the final adjudication of this matter, UFC will amend all necessary filings. Currently, Mr. Leal has not responded to the pleadings filed against him and UFC has taken all steps necessary to pursue a judgment against Mr. Leal.
4. UFC did not fraudulently misrepresented Mr. Leal on any filings.
5. Attached to this email are bank statements from Ms. Urbina's personal account demonstrating payment for clothing worn to campaign events and activities. These were not accounted for on any campaign filings because Ms. Urbina also wore these garments on other occasions; thus, it was not a campaign expense.
6. The Complainant has filed frivolous charges in multiple forums in an attempt to further sabotage Urbina for Congress and Briana Urbina personally. These allegations are nothing more than the ramblings of a disgruntled, dismissed team member with a grudge.
