

1. On September 7, 2019 Congressman Bill Posey held a fundraising event at the Muscle Car Museum in Melbourne FL. The flyer for this event is attached. Admission CELA was a "donation" of a minimum of \$5 per person in order to tour the museum, meet Bill Posey, and ride in exotic vehicles. Bill Posey stated on his Facebook page that well over 800 patrons showed up. He subsequently posted over 100 photographs documenting the success of the event.







2. The Muscle Car Museum owned by Mark Pieloch is a 501c(3) non-profit corporation. It is not open to the public and holds numerous fundraisers throughout the year for many different organizations in the community. Because of it's tax exempt status, it is prohibited from giving to political organizations. Because of it's corporation status, federal campaigns cannot receive donations from them. The organization and the campaign both violated these laws.

3. However, the regular entry price to the museum is and has been \$100 per person. This was the same amount that Posey charged last year for the same fundraising event. By the museum discounting the admission price by 95%, this counts as a \$95 in-kind donation to the campaign from the corporation. Each person who attended (over 800) counts as a separate violation and contribution.






Besides the fact that these contributions were illegal, there are zero in-kind contributions from the museum reflected in Mr. Posey's campaign finance reports, and there are only 3 monetary donations listed from the over 800 attendees at the fundraising event. There are also no expenditures listed from the campaign to the museum. This is also true for the same event hosted last year and the campaign finance reports from the 2018 election.
