This office represents the American Muscle Car Museum, Inc. in connection with Matter Under Review ("MUR") 7707. Enclosed please find executed Designation of Counsel from the Respondent. Please note that Mr. Pieloch is not the "owner" of the American Muscle Car Museum. As a non-profit organization, the museum has no "owner." Mr. Pieloch serves as President of the museum.

On March 3, 2020, the Respondent received the Commission's notice of the complaint. The notice affords the Respondent 15 days to submit a response pursuant to 52 U.S.C. § 30109(a)(1). Respondent intends to submit a response but will need an additional 30 days, until April 17, 2020, to do so.

Good cause exists for granting this modest extension. Our firm was engaged this week.
