The League of Conservation Voters Action Fund (“LCVAF”), and Patrick Collins, as Treasurer, have become aware of a complaint that mentions LCVAF in the above-referenced matter under review. Due to the closure of its offices in light of the COVID-19 pandemic, LCVAF has been unable to check the mail on a regular basis. Although LCVAF has not formally received a notification of the complaint from the Commission, LCVAF received the complaint from another named respondent, Montana Conservation Voters Action Fund, and assumes that the Commission has sent the complaint and, due to disruption in the mail, it has not been delivered or received.

This letter is to request a 21-day extension of time to respond to the complaint. For purposes of this letter and filing a response, LCVAF will consider that it received the complaint on April 13, 2020; with this extension, the response will be due May 18, 2020. We have also enclosed a designation of counsel.
