- h. Take no action at this time as to the allegation that David Brock violated the Federal Election Campaign Act of 1971, as amended.

Dismiss the allegation that AB PAC and Rodell Mollineau in his official capacity as treasurer violated 52 U.S.C. §§ 30104(b)(6)(B)(i), 30116(a)(2)(A) and 11 C.F.R. §§ 104.3(b), 110.2(b) by making and failing to report excessive in-kind contributions to Hillary for America and Elizabeth Jones in her official capacity as treasurer and unknown committees.

Dismiss the allegation that Hillary for America and Elizabeth Jones in her official capacity as treasurer and unknown committees violated 52 U.S.C. §§ 30104(b)(3)(A), 30116(f) and 11 C.F.R. §§ 104.3(a), 110.9 by knowingly accepting and failing to report excessive in-kind contributions from AB PAC and Rodell Mollineau in his official capacity as treasurer.
- k. Authorize the use of compulsory process.
