

To Whom this May Concern

My name is Mary Jean Dowell, , Vancouver, WA 98684, , and available at email . My ssn is . I am writing to file a complaint because I believe voter fraud was performed in my name, via donations made to either the RNC or to the Trump campaign in my name, but not by me.

Last month I received a letter from the RNC stating that I made \$277.70 in campaign donations in 2019. At first I threw the letter away and ignored it knowing it was a mistake. As I thought about it and researched my bank statements, and now I believe there were fraudulent campaign contributions made in my name.

I did make four legitimate purchases in November 2019 to add to my history collection; three were to the Trump Campaign and one to the Trump Hotel Store. I made no other purchases or donations to the campaign or to the RNC in 2019. I am a regular donor to the DNC and their candidates, and frequently make \$2 to \$5 donations in response to polling.

The legitimate purchases are:

- Nov 10- Trump MAGA \$46.69, including \$30 wood train and \$16.69 shipping
- Nov 21- Trump MAGA \$10.98, including \$5 Official T shirt & \$5.98 shipping
- Nov 21- Trump Store \$17.98, including \$16 for 4 mugs, & 1.98 shipping
- Nov 27- Trump Maga \$79.69 but I can't remember the shipping/purchase prices. Packing lists are enclosed. I do not have actual invoices for any of these online purchases.

My most probable suspicion is that someone made a donation in my name to both bypass the \$2,800 ceiling AND attached my name as a Trump supporter.

Ironically Trump and I are legally entangled in the real world in a MSPB Whistleblower reprisal case that I filed with Office of Special Counsel in October 2016, immediately before the election. My case is a bellwether case and was the first to go to trial under the new WEPA12 Act. Rulings from my case were quoted by both Yavonivich and Schiff during the impeachment proceedings. In my suspicions, the Campaign sees my support as a campaign trophy because of the MSPB ruling. Given my legal relationship with Trump, and his history of dirty cheating in elections, I would like to file a complaint for campaign fraud.

I make this statement freely. I swear the above statement is true and accurate.



Dear Ms. Dowell:

This is in response to your email received on March 30, 2020. The Federal Election Commission (the "Commission") has jurisdiction over the Federal Election Campaign Act of 1971, as amended (the "Act") and Chapters 95 and 96 of Title 26, United States Code. The 1976 amendments to the Act and Commission regulations require that a complaint meet certain specific requirements. Your email did not meet these requirements. In particular, your correspondence was not sworn to and notarized, as required under the Act. Additionally, your correspondence did not include a clear and concise recitation of facts describing violations of the Act over which the Commission has jurisdiction. Consequently, the Commission can take no action at this time unless the allegations are refiled meeting the requirements for a properly filed complaint. Please see language in **bold** below concerning the Commission's current processing procedures.

If you desire the Commission to look into the matters discussed in your email, please provide specific details regarding each allegation and how they violate the Act. Requirements of the Act and Commission regulations at 11 C.F.R. § 111.4, which are a prerequisite to Commission action, are detailed below:

- (1) A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction (11 C.F.R. § 111.4).
- (2) Its contents must be sworn to and signed in the presence of a notary public and shall be notarized. (52 U.S.C. § 30109(a)(1)). The notary must indicate as part of the jurat that such swearing occurred. The preferred form is "Subscribed and sworn to before me on this \_\_\_ day of \_\_\_, \_\_\_\_."
- (3) A formal complaint should be accompanied by supporting documentation if known and available to the person making the complaint. (11 C.F.R. § 111.4).
- (4) A complaint must be in writing. (52 U.S.C. § 30109(a)(1)). *As noted below, during this time, a complaint may be emailed if you are in a state in which electronic notarization is available.*
- (5) A formal complaint must contain the full name and address of the person making the complaint. (11 C.F.R. § 111.4).
- (6) A formal complaint should clearly identify as a respondent each person or entity who is alleged to have committed a violation. (11 C.F.R. § 111.4).
- (7) A formal complaint should identify the source of information upon which the complaint is based. (11 C.F.R. § 111.4).

Please note that this matter will remain confidential for a 15 day period to allow you to correct the defects in your complaint. **Any corrections to your complaint must be submitted in writing to the General Counsel at the FEC's street address, or submitted by email to [cela@fec.gov](mailto:cela@fec.gov), if you are in a state in which electronic notarization is permissible.**

**As indicated in the FEC's Notice found at [https://www.fec.gov/resources/cms-content/documents/website\\_notice\\_regarding\\_status\\_of\\_operations\\_3-26-2020.pdf](https://www.fec.gov/resources/cms-content/documents/website_notice_regarding_status_of_operations_3-26-2020.pdf), the office's mailroom is not processing correspondence at this time. Therefore, if you file a corrected complaint by mail or delivery service, the Commission requests that you *also* send an electronic copy of the corrected complaint to [cela@fec.gov](mailto:cela@fec.gov).**

**The FEC encourages the use of electronic signatures on, and electronic notarizations of, such electronically submitted complaints from states in which electronic notarization is available. Electronically submitted copies of corrected complaints that otherwise appear to be in order will be deemed received on the date the copy was electronically received by staff. Corrected complaints that are filed only on paper, via mail or delivery service, will be deemed received within 24 hours after the agency resumes normal mail operations.**

If the complaint is corrected and refiled within the 15 day period, the respondents will be so informed and provided a copy of the corrected complaint. If the complaint is not corrected, the file will be closed and no additional notification will be provided to the respondents.

I believe the Trump Campaign kept my debit card data from a legitimate purchase, and then made a \$200 donation in my name without my knowledge or approval. Specifically...

Within the last two weeks I received a letter from the RNC stating I donated \$270 in 2019. At first I ignored it thinking it was a mistake. I checked my bank for the past 4 months but didnt see a charge. The purchases didnt show either. After thinking about it for a week, now I'm suspicious I've been a victim of foul play in election campaign finance.

In 2019 I did buy online \$70 worth of purchases from the Trump Campaign for my history collection. I also purchased four Trump golfcourse coffee mugs for \$5 each from Trump Hotels. But I have NOT made another cash contribution, either to the RNC or to the Trump Campaign directly.

My dirtiest, darkest suspicions think the Trump hotels used my debit card data, and made a \$200 contribution, **STEALING MONEY FROM ME!**

My most probable suspicion is that someone made an anonymous donation in my name to both bypass the \$2800 ceiling AND attached my name as a Trump supporter.

Ironically Trump and I are real world legally entangled together in a MSPB Whistleblower reprisal case that I filed with Special Counsel in 2016. Rulings from my case were quoted by both Yavonivich and Schiff during the impeachment proceedings. In my suspicions, the Campaign sees my support as a campaign trophy.

What I seek from the FEC is a quick review of donations to TRUMP/RNC and review the details of the phantom \$200. Also to assist if fraudulent contributions can be refunded as necessary.

Given my legal relationship with Trump, and his history of dirty cheating in elections, I would like an answer to what you uncover.
