RE: Friends of Jason Atkinson Committee - Failure to Report Debts Owed

Dear Office of General Counsel:

This Complaint is filed by Ryan B. Horn, as President of Bullhorn Communications, LLC, a Nebraska limited liability company ("Bullhorn"). My address is 5016 Webster Street, Omaha, NE 68132. This Complaint is filed with regard to the inaccurate and incomplete committee filings made by Friends of Jason Atkinson (ID: C00726786) (the "Atkinson Committee") for the campaign of Jason Atkinson as a Republican candidate for the House of Representatives for Oregon's 2nd Congressional District (ID: H00R02135). Specifically, the Atkinson Committee's FEC Form 3 (Filing FEC-1404655) filed on May 7, 2020 (the "Initial Form 3") and amended on May 14, 2020 (FEC-1405687) (the "Amended Form 3"), covering the period from April 1, 2020 to April 29, 2020 fails to accurately report a debt in the amount of \$18,388.95 (excluding interest) owed to Bullhorn Communications, LLC ("Bullhorn"). A copy of the Initial Form 3 is included as Exhibit A and a copy of the Amended Form 3 is included as Exhibit B.

Bullhorn provided advertising strategy, consulting, and production services (the "Services") to the Atkinson Campaign pursuant to the Political Agency and Consulting Services Agreement, dated February 2, 2020 (the "Agreement"). A copy of the Agreement is included as <a href="Exhibit C">Exhibit C</a>. As of April 29, 2020, the Atkinson Committee owed Bullhorn the following amounts:

Copies of the invoices are included as Exhibit D.

Despite repeatedly sending the invoices to the Atkinson Committee's campaign manager, Jim Dornan, and to candidate Jason Atkinson, Bullhorn had not received any payments for these invoices. As a result, Bullhorn engaged its legal counsel to assist in the dispute. The following is a timeline of the key events.

- April 28, 2020: Bullhorn's legal counsel sent a demand letter to the Atkinson Committee on April 28, 2020; the demand letter was sent via email to Mr. Dornan and Mr. Atkinson, with a copy sent by FedEx in accordance with the Agreement. A copy of the demand letter is included as Exhibit E.
- May 4-5, 2020: In response to the demand letter, the Atkinson Committee's legal counsel contacted Bullhorn's legal counsel on May 4, 2020 to set up a call on May 5, 2020. In discussions on May 5, 2020, the Atkinson Committee's legal counsel acknowledged that the failure to pay was merely a cash flow issue and did not relate to any dispute; the Atkinson Committee's legal counsel stated that the Atkinson Committee intended to pay but needed some flexibility with a payment plan.
- May 7-9, 2020: After further negotiation, the Atkinson Committee agreed on May 7, 2020 to make a partial payment to Bullhorn in the amount of \$4,000, subject to a more detailed payment plan to be agreed and with "every effort to pay off the alleged balance owed" by June 30, 2020. On May 8, 2020, Bullhorn agreed to accept the initial \$4,000 payment and find a mutually agreeable payment plan as funds were available. Also on May 8, Bullhorn's legal counsel obtained access to and reviewed the Initial Form 3 and notified the Atkinson Committee's legal counsel that it failed to report the debt owed to Bullhorn. As a courtesy, Bullhorn gave the Atkinson Committee the opportunity to amend the Initial Form 3 on its own. The agreed initial \$4,000 payment was subsequently sent by the Atkinson Committee on May 8, 2020 and received by Bullhorn on May 9, 2020.
- May 11-14: On May 11, 2020, the Atkinson Committee's legal counsel indicated that it was still
  actively fundraising and intended to make a payment of a to-be-agreed upon amount by May 15,
  2020. On May 13, 2020, the Atkinson Committee's legal counsel indicated that the Atkinson

Committee was "not able to come up with a number that it can commit to" for payment on May 15, 2020. After Bullhorn's counsel responded to inquire about the amendment of Initial Form 3 to reflect the debt, the Atkinson Committee's legal counsel responded that the campaign was still "looking into it." On the morning of May 14, 2020, Bullhorn's counsel reminded the Atkinson Committee's legal counsel of the specific debt reporting obligations under the regulations issued by the Federal Election Commission to implement the Federal Election Campaign Act of 1971, as amended, and asked for proof of an amended filing. At 4:50 p.m. CST, Mr. Dornan provided confirmation of the amended filing. The amended filing reports a debt of only \$17,016.86 (omitting the \$1,372.09 owed pursuant to Invoice 1069). In addition, the debts reported are marked with "Debt Contest." This appears to be an effort to dispute the debts reported, even though the Atkinson Committee had never disputed the debts in any previous discussions. Note, even if disputed, the reporting was still incorrect in accordance with the regulations.

- May 15-19: Despite the Revised Form 3 reporting a "debt contest" for all amounts reported, on May 15, 2020, Atkinson Committee's counsel committed to make another payment. On May 18, 2020, the Atkinson Committee sent a payment for \$1,000, which was received by Bullhorn on May 19, 2020.
- May 20: On May 20, 2020, Jason Atkinson lost the primary as a Republican candidate for the House of Representatives for Oregon's 2nd Congressional District. After inquiry from Bullhorn's counsel on May 21, 2020, Atkinson Committee's counsel responded that "there is likely nothing left" and "further efforts to collect" would not "be fruitful;" he also indicated he had withdrawn from representation of the campaign.

Campaign debts must be reported continuously until paid on FEC Form 3. 11 C.F.R. §§ 104.3(d) and 104.11. This includes unpaid bills and written contracts or agreements to make expenditures. 11 C.F.R. § 100.112. A debt exceeding \$500 must be reported in the report covering the date on which the debt was incurred. 11 C.F.R. §§ 104.3(d), 104.11, and 116.6(c). The debt must be reported in total on the Summary Page and itemized by creditor on Schedule D. Despite the Agreement, the invoices, and the demand letter, the Atkinson Committee failed to report any of the debt owed to Bullhorn on the Initial Form 3. Only once its hand was forced did the Atkinson Committee file an amendment and, for the first time, disputed the debt. Even then the Amended Form 3 does not comply with reporting requirements for a disputed debt. "Until the dispute is resolved, the political committee shall disclose on the appropriate reports any amounts paid to the creditor, any amount the political committee admits it owes and the amount the creditor claims is owed." 11 C.F.R. § 100.10. At a minimum, the Amended Form 3 does not reflect the amount Bullhorn claims it is owed by omitting Invoice 1069. In addition, based on information and belief, the Amended Form 3 purports for the first time that there was a "debt contest" and subsequent correspondence (including subsequent payment of \$1,000) lead the undersigned to believe that there is no bona fide dispute as to the existence or amount of the debt.

As of the date of this Complaint, the Atkinson Committee owes Bullhorn \$15,263.30 under the Agreement (excluding interest and commissions on media buys after April 29, 2020). This includes the \$18,388.95 as owed on April 28, 2020, less the payments received totaling \$5,000.00, plus \$1,874.35 for





additional media commissions.<sup>3</sup> Upon information and belief from a review of filings with the Federal Communications Commission, the Aktinson Committee continued airing media in May 2020, which would also result in additional media commissions and increase the amount owed. Despite not paying Bullhorn for its work producing advertisements, the Atkinson Committee improperly aired the advertising that Bullhorn created (and incurred expenses to air such advertising).

Presuming that the remainder of the Amended Form 3 was accurate and complete as required by law, then the Atkinson Committee had sufficient cash to pay Bullhorn. The Amended Form 3 reported cash of \$16,414.83 as of April 29, 2020. As of the date of this Complaint, the Atkinson Committee had reported an additional 22 contributions totaling \$38,200.00 to the FEC (via 14 FEC Forms 6), resulting in total cash of \$54,614.83. No other debts were reported on the Amended Form 3. Thus, it appears that the Atkinson Committee had cash on hand to pay a substantial part, if not all, of the debt owed to Bullhorn. Instead, the Atkinson Committee consciously chose not to pay the debt legitimately owed to Bullhorn and, instead, used funds to make other discretionary purchases (e.g., media buys). Furthermore, based on the past conduct of the Atkinson Committee, Bullhorn fears that the Atkinson Committee will not comply with the requirements for debt settlements. See, e.g., 11 C.F.R. §§ 116.7 (prohibiting filling a termination report until each debt has either been paid in full, settled, forgiven, or otherwise discharged) and 116.10(b) (requiring the committee to describe efforts to resolve disputed debts).

In conclusion, despite being given reasonable opportunity to accurately report and pay its debts, the Friends of Jason Atkinson (ID: C00726786) for the campaign of Jason Atkinson as a Republican candidate for the House of Representatives for Oregon's 2nd Congressional District (ID: H00R02135) has violated the regulations of the Federal Election Commission. ### POLITICAL AGENCY AND CONSULTING SERVICES AGREEMENT

This Political Agency and Consulting Services Agreement (this "Agreement") is made and entered into by and between Bullhorn Communications, LLC, a Nebraska limited liability company ("Bullhorn"), and Friends of Jason Atkinson, a Political Campaign ("Client"). Bullhorn and Client are individually referred to herein as a "Party" or collectively as the "Parties." In consideration of the mutual covenants set forth in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bullhorn and Client, each intending to be legally bound, hereby agree as follows:

- 1. <u>Services.</u> Bullhorn shall provide advertising strategy, consulting, and production services to Client with regard to Jason Atkinson's campaign for Congress (the "Services"). The Services will include, but are not limited to (a) strategic and organizational consulting, (b) theme and message development, (c) communications consulting and advice, (d) advertising campaign planning and budget development, (e) conception and production of all television, radio, and digital spots, and (f) "Creative Director" consulting for weekly social media videos to not exceed 40 hours per month. Bullhorn represents and warrants that the Services will be performed (x) in a professional and timely manner consistent with standards in the political advertising and consulting industry, (y) in compliance with all applicable federal, state, and local laws, and (z) by individuals with appropriate training, background, knowledge, and skills.
  - a. The Client agrees that Bullhorn shall have vendor authority in production related processes as applied to traditional and premium digital advertising, (Broadcast Television, Cable, Radio, and Premium Digital Advertising [e.g. Hulu and other full episode premium OTT Platforms])
- **2.** Agency Appointment. Client authorizes and appoints Bullhorn as its agent to provide the Services, exercise Bullhorn's powers and authorities, and discharge Bullhorn's obligations, all as set forth in this Agreement. Bullhorn accepts appointment as agent for Client and agrees to provide the Services as set forth in this Agreement.
- 3. <u>Term.</u> This Agreement shall commence on the date this fully signed Agreement is returned by Client and accepted by Bullhorn, and shall remain in force and effect until November 2020, unless earlier terminated or extended in accordance with Section 12 of this Agreement (the "Term").
- **4.** <u>Compensation.</u> As compensation for the Services, Client shall pay Bullhorn the Monthly Fee (as hereinafter defined), plus the Media Commission (as hereinafter defined, including the Minimum Media Commission).
  - a. <u>Creative Director Fee.</u> Client shall pay Bullhorn a monthly creative fee (the "Creative Director Fee"). The Creative Director Fee is due and payable in advance, on the 15th calendar day of each month, and whose time shall not exceed more than 40 hours per month. Agency time in excess of 40 hours in a calendar month will be billed at \$150/hour with the notice to, and written approval from, the campaign. The creative retainer will be billed according to the following schedule: \$2500 on January 15; \$2500 on February 15; \$7500 on March 15; and \$7500 on April 15. In addition, Bullhorn will receive a win bonus of \$10,000 upon Jason winning the May 19 primary election

**b.** <u>Creative Media Commission.</u> Client shall pay Bullhorn a media commission in accordance with the following marginal schedule (the "Media Commission"):

Gross Media Buys	Media Commission Percentage
First \$500,000	9.5%

Second \$500,000	7.5%
(\$501,000-\$1,000,000)	
All Additional	5.0%
(\$1,000,001 and above)	

The Creative Commission is due and payable concurrently with placement of the related media buy. Commissions are calculated on all advertising utilizing bullhorn produced content, across both traditional and digital ad platforms. All commission provisions of this contract expire November 30, 2020.

#### 5. Expenses.

- **General Reimbursement Policy.** Client shall reimburse Bullhorn for reasonable and customary out-of-pocket expenses actually incurred by Bullhorn related to the Services, including but not limited to travel and shipping, provided that Bullhorn obtains prior approval from Client for all expenses that are estimated to exceed \$500. Supporting documentation for all items submitted for reimbursement shall be provided upon request.
- b. Production Costs. One half (1/2) of all estimated production costs shall be due and payable by Client to Bullhorn no less than five (5) business days prior to the start of production. The remaining one half (1/2) of estimated production costs shall be due and payable by Client to Bullhorn prior to or concurrently with delivery of the finished product to Client or to media outlets. Within fifteen (15) days after delivery of the finished product, Bullhorn will provide a final invoice reconciling the estimated production costs to actual production costs, and reflecting the remainder due from Client or the credit due to Client, as applicable.
- **c.** <u>Media Buys.</u> The full cost of all media buys shall be due and payable by Client concurrently with placement of the related media buy.
- **Escrow Account.** If deemed necessary and appropriate by Bullhorn, Bullhorn in its discretion may establish an escrow account with an escrow agent to hold Client's funds for future payment to third parties, including but not limited to media and other service providers, or to Bullhorn for compensation and expenses. If so established, the escrow account shall be in the name and tax identification number of Client. Client shall deposit funds into the escrow account in such amounts and at such times as requested by Bullhorn. All funds held by the escrow agent in the escrow account shall belong to Client until dispersed in accordance with this Agreement, and any amounts remaining in the escrow account at the end of the Term shall be returned to Client. Client authorizes Bullhorn to make disbursements from the escrow account to third parties and/or to Bullhorn when Bullhorn determines that sums are due to such third parties or Bullhorn under the terms of this Agreement. Client authorizes Bullhorn to provide a copy of this Agreement to the escrow agent as evidence of Bullhorn's authority under this Agreement. Client authorizes the escrow agent to provide a copy of and access to any and all periodic statements and other reports of the escrow account to Bullhorn. Client shall execute any and all documents required by the escrow agent so as to authorize and enable Bullhorn to exercise its



authority in accordance with this Section 6. In the event Bullhorn does not elect to establish an escrow account, Client shall be responsible for paying third parties and Bullhorn directly.

- 7. <u>Invoices.</u> Bullhorn shall invoice Client on a periodic basis for all compensation and expenses payable. Invoices shall reflect all prepaid amounts, all amounts distributed from any escrow account, and all amounts remaining due for the period covered by the invoice. Client shall pay each invoice in full within fifteen (15) days after the invoice date. If any portion of any invoice remains unpaid for more than thirty (30) days following the invoice date, Bullhorn may impose interest at the rate of one percent (1%) per month, suspend the Services, terminate this Agreement, and take any other action permitted by law.
- **Communications.** Bullhorn and Client will communicate through appropriate personnel of each Party. Bullhorn may communicate with Client and others through email or other internet-based communications, may electronically store documents related to the Services, and may use select third-party vendors to facilitate electronic communications and storage. Any written notices required by this Agreement shall be delivered personally, by certified mail (costs prepaid), or by reputable overnight courier (costs prepaid) to the address set forth after the signature block of this Agreement.
- 9. Confidentiality. Confidential Information (as hereinafter defined) shall be held in strict confidence by Bullhorn, using at least a reasonable degree of care and diligence. Confidential Information may be used and disclosed only in furtherance of providing the Services. "Confidential Information" shall consist of all data, material, and information, in whatever form, disclosed by Client to Bullhorn and which relates to the Services, together with analyses, compilations, forecasts, studies, or other documents prepared by Bullhorn using such information, whether or not marked as "confidential." Confidential Information shall not include any information that (a) is or becomes part of the public domain through no fault of Bullhorn, (b) was rightfully in Bullhorn's possession without restriction at the time of disclosure, (c) is received from a third party when such third party, to Bullhorn's knowledge, did not acquire such information subject to confidentiality restrictions in favor of Client, or (d) is independently developed by Bullhorn without reliance upon Confidential Information. If Bullhorn is required by any legal body to disclose any Confidential Information, in whole or in part, then Bullhorn shall, to the extent legally permitted, provide Client with prompt notice in order to afford Client an opportunity to seek an appropriate protective order. After termination of this Agreement and full payment of all compensation and expenses in accordance with this Agreement, Client may request Bullhorn to return all Confidential Information to Client at Client's cost and expense, provided that Bullhorn may retain copies to the extent necessary to comply with applicable federal, state, or local laws.
- **Intellectual Property.** Upon full payment of all compensation and expenses in accordance with this Agreement, all ownership and intellectual property rights, title, and interest to the work product generated in conjunction with the Services (the "Work Product") shall belong solely to Client as work made for hire. Notwithstanding the foregoing, (a) the Work Product excludes and Bullhorn retains ownership and rights, title, and interest to all concepts, know-how, tools, frameworks, models, and perspectives developed or enhanced by Bullhorn in connection with the Services, provided that such items do not contain Confidential Information, and (b) Client hereby grants Bullhorn an non-exclusive, royalty-free, perpetual license to use and display any Work Product that has been publicly distributed as part of the Services (e.g., television spots, written advertisements), together with Client's name, trade name, trademark, service mark, logo, or other designation, for Bullhorn's own advertising, publicity, promotion, and marketing purposes. At Client's request and expense, Bullhorn will assist and cooperate with Client, execute documents, and take such further acts reasonably requested by Client to enable Client to acquire, transfer, maintain, perfect and enforce its intellectual property rights and other legal protections for the Work Product.
- 11. <u>Independent Contractor.</u> Bullhorn is an independent contractor of Client. Bullhorn will perform the Services at the general direction of Client, but Bullhorn will determine, in Bullhorn's sole discretion, the manner and means by which the Services are accomplished.



- **Termination.** Either Party may terminate this Agreement (a) for cause, if the other Party commits a material breach of this Agreement that remains uncured for ten (10) days after written notice of the material breach, and (b) for convenience, at any time and for any or no reason on at least thirty (30) days written notice. No Services in progress shall be completed after the effective date of termination, unless requested and paid for by Client in advance. Upon the termination of the Contract for any reason, including expiration of the Term, Client shall pay for all compensation and expenses up to the effective date of termination. Upon the termination of the Agreement prior to the end of the Term (x) by Bullhorn for cause, or (y) by Client for convenience, Client shall immediately pay Bullhorn in full a termination charge of \$5,000 per month multiplied by the remaining months of the primary election retainer schedule in 4(a). The Parties acknowledge that the termination charge represents liquidated damages, and not a penalty, because Bullhorn has foregone other work in anticipation of the time and effort required for the Services to be provided to Client for the Term of this Agreement, and in light of the time and effort required for Bullhorn to acquire comparable replacement work.
- 13. <u>Limitation of Liability.</u> To the maximum extent permitted by law, in no event shall Bullhorn (a) be liable for consequential, indirect, incidental, special, punitive, lost profits, or any other non-direct damages of any character and under any theory of recovery, (b) be liable for amounts in excess of the total amount of compensation paid for Services under this Agreement, or (c) be liable with respect to its Services except for any loss directly attributable to Bullhorn's gross negligence or willful misconduct. Client shall indemnify, defend, release, and hold harmless Bullhorn, its officers, members, managers, employees, or agents for any loss, liability, cost, damage, or expense, including reasonable attorneys' fees, that does not directly result from Bullhorn's gross negligence or willful misconduct. Except as expressly set forth herein, neither Party makes any other representations or warranties, express or implied.
- 14. <u>Dispute Resolution.</u> If any controversy or claim arises out of or relates to this Agreement, or the alleged breach hereof, the Party claiming dispute shall give notice to the other Party specifying the particulars of the dispute in reasonable detail. The Parties shall meet and negotiate in good faith using best efforts to resolve such controversy or claim. If not resolved within thirty (30) days after notice is given, the controversy or claim shall be finally resolved by arbitration conducted in Omaha, Nebraska in accordance with the Nebraska Uniform Arbitration Act and the thencurrent commercial rules and procedures of the American Arbitration Association. The independent arbitrator will be mutually selected by the Parties; if the Parties cannot mutually agree, the American Arbitration Association shall provide the arbitrator. The Parties shall equally share the cost of the independent arbitrator. In addition to any other relief determined by the arbitrator, the prevailing Party shall be entitled to an award of its reasonable costs and expenses, including but not limited to attorneys' fees. All decisions of the arbitrator will be final and binding and may be entered into any court of competent jurisdiction. The Parties hereby waive any right to have the controversy or claim litigated in court.
- **15. Miscellaneous.** This Agreement constitutes the entire agreement among the Parties pertaining to the Services and supersedes all prior contracts, agreements, understandings, negotiations, and discussions, whether oral or written. Any amendment to this Agreement or any waiver of any of the rights or obligations created herein shall be in writing and signed by all Parties. No failure or delay by any Party in exercising any right, power, or privilege hereunder shall operate as a waiver thereof nor shall any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, power, or privilege. This Agreement shall be governed, construed, and interpreted in accordance with Nebraska law, without regard to conflict of laws principles. If any term or condition of this Agreement is determined to be invalid or unenforceable, then it shall not affect any other term or condition of this Agreement, each of which will continue in full force and effect. All rights, remedies, obligations, covenants, and agreements in this Agreement which, by their terms, require or contemplate performance which is to extend beyond or occur after the termination of this Agreement, shall survive the termination and shall remain in effect and be enforceable against the Parties in accordance with their terms. This Agreement, and the rights and obligations hereunder, may not be assigned by either Party without the prior written consent of the other Party. This Agreement is for the sole benefit of the Parties hereto, and nothing herein is intended to confer any rights or remedies on or discharge any obligation or liability to any third persons.



**Execution.** Each Party represents and warrants that the execution and delivery of this Agreement have been duly authorized, and this Agreement constitutes a valid and binding obligation of such Party. This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. This Agreement may be executed and delivered electronically, whether by an electronic signature and delivery service or by electronically transmitting physically signed copies by facsimile or electronic mail, each of which shall be binding and shall be construed as an original.
