Re: Complaint against Respondents Paul J. Romero, Jr. (S0OR00337); Romero for Senate (C00725523); Friends of Paul J Romero Jr. (C00615625); Mr. Wade Barrett, Treasurer of Friends of Paul J Romero Jr.; and Ms. Lynette Boniface, Treasurer of Romero for Senate.

To whom it may concern:

My name is Dominic Stevenson, and I am writing in regards to Mr. Romero's campaign for U.S. Senate. I believe Mr. Romero, Romero for Senate, Friends of Paul J Romero Jr., Mr. Wade Barrett, and Ms. Lynette Boniface have committed multiple violations of the Federal Election Campaign Act of 1971.

#### **Facts**

Friends of Paul J Romero Jr. filed a statement of organization with the FEC on April 25, 2016 (Exhibit A), while no statement of candidacy was filed by Mr. Romero for the 2016 election cycle, I presume that he was an active candidate in this election as the treasurer for his committee declared, under penalties of perjury, that he was a candidate for Oregon's second Congressional district.

While Mr. Romero was ultimately defeated in the primary election on May 17, 2016, Mr. Romero's principal campaign committee for this election, Friends of Paul J Romero Jr., never filed a termination statement with the FEC.

Mr. Romero subsequently declared his candidacy for U.S. Senator of Oregon by filing a statement of candidacy with the Federal Election Commission declaring his principal campaign committee to be "Romero for Senate". (Exhibit B) on November 1, 2019. That same day, a statement of organization was filed for Romero for Senate (Exhibit C). Mr. Romero has been actively campaigning since declaring his candidacy. Neither of those filings contained any designations of other authorized committees.

A report detailing all contributions and expenditures during the fourth quarter of 2019 was due to be filed on January 31, 2020 by Romero for Senate. On January 31, 2020 they filed a miscellaneous report to the FEC stating they had not met a \$5,000 threshold for filing purposes (Exhibit D), I believe this relates to 52 USE 30101(2), which states that an individual becomes a candidate after raising \$5,000 during an election cycle. Mr. Romero and Ms. Lynette Boniface seem to misunderstand the law. It's my understanding that he became a candidate when he filed his statement of candidacy with the FEC on November 1, 2019.

Mr. Romero has been actively campaigning in the State of Oregon. He has a campaign website, (Exhibit E), a Facebook page (Exhibit F) and he has put yard signs across the State (Exhibit G). While his campaign website does not have a formal disclosure stating whom it was paid for by, a reasonable person would assume based on the presentation, that it was paid for by Friends of Paul J Romero Jr. or this entity, which has not filed with the FEC as a campaign committee for Mr. Romero's run for Senate, presumably has made disbursements for these items, or at the very least incurred debt, but as no financial reports have been filed for this committee, nor has Mr. Romero's principal campaign committee filed any reports disclosing any sources of funding or expenditures, a reasonable person is left to wonder if Mr. Romero is intentionally concealing the illegal corporate contributions to his campaign.

Mr. Romero also has an active donation portal through the conduit PAC, WinRed, which states that a contribution will benefit "Friends of Paul Romero" (Exhibit H). WinRed requires an FEC ID in order to approve a new account yet "Friends of Paul Romero" does not exist in any records I was able to find.

Additionally, his current campaign Facebook page lists the title as "Paul Joseph Romero Jr. for Congress, US Senator, Oregon" (Exhibit I). Lastly, the signs that are around the state and posted on his campaign's public Facebook page, disclose that they were also paid for by Friends of Paul Romero for Senate (Exhibit J). I searched the FEC and cannot find a record of either such committee.

#### Conclusions

Mr. Romero is intentionally concealing the source of funding for his campaign by avoiding filing the required reports with the FEC and disclaiming advertisements paid for by campaign committees that do not exist, or perhaps does not know the name of his own campaign committee, which he designated under penalties of perjury in his statement of candidacy.

These Committees and Candidate have confused me, and I can only imagine numerous other voters with lack of filings, duplicative committees, and inconsistent information being disseminated to the public. I appreciate your attention and thank you for your consideration in this matter.




Romero raised five children — three biological kids and two nieces — as a single parent after his and his wife divorced.


