Re: NC NAACP Complaint against Faith and Power PAC, C00736751.

Dear General Counsel and Members of the Federal Election Commission:

The North Carolina State Conference of NAACP Branches ("NC NAACP") files this historical case against Faith and Power Pac, FEC File C00736751. I am Rev. Dr. T. Anthony Spearman, the Complainant. I have sworn to this statement below, per your instructions. Please call me at my office with any questions. On information and belief, I allege:

- 1.0n 29 January 2020 'Ezekiel Patterson' electronically signed **FEC Form 1** and filed it with the FEC. This **'Statement of Organization'** is attached to this Complaint as Exhibit 1, and is expressly incorporated in this complaint, as are all FEC Forms attached as Exhibits.
- 2.Mr. Ezekiel Patterson, at all times material to this complaint, knew he was working for the national Republican Party to support the re-election of Sen. Thom Tillis to the United States Senate. All of Mr. Patterson's paymasters knew the FEC prohibits the scam described in this complaint. Mr. Patterson and those acting in concert with him knew, as Ex. 1 states, that "Submission of false, erroneous, or incomplete information may subject the person signing this Statement to the penalties of 2 U.S. C. d 437g. Any change in information should be reported within 10 days."
- 3.Exhibit 2, incorporated in this Complaint, itemized the first major contributions to the just-formed Faith and Power Pac. Mr. Patterson used a mailing address in Jacksonville, NC when he reported to the FEC that the first contributor to Faith and Power Pac is the "Senate Leadership Fund" located at 45 North Hill Drive, Ste 100, Warrenton, Virginia.' This is a Republican Party front, which we allege on information and belief, spent every penny it contributed to Mr. Patterson's Faith and Power Pac to fully support the re-election of Sen. Thom Tillis. Mr. Patterson and his confederates in Warrenton, Virginia, were aware that the NC NAACP has been actively re-building the moral fusion alliance of white-blackbrown electorate, which has brought light and hope to the Tar Heel State.
- 4.The **Senate Leadership Fund** up in the DC suburbs in Warrenton contributed millions of dollars to promote this obvious race-based wedge tactic to confuse progressive Black and White voters, deliberately creating bad blood between the two main competitors in the Democratic Primary. On information and belief, the wedge-experts in Warrenton named their NC paper outfit **Faith and Power Pac** deliberately to confuse older African American voters and their friends, because every Black Christian, including your Complainant, knows the "faith" Jesus lived and taught was the ark that kept African slaves and their descendants afloat during the 250 years of slavery and Jim Crow in the rural and urbanizing south. Most unreconstructed white politicians have taken cover behind a distorted history of Jesus and Moses, to



rationalize their discriminatory day-time policies and night-time terror against Black and Fusion Electorates across the south, including North Carolina.

5.0n1/31/2020 the Senate Leadership Fund contributed \$2,450,000.00 to the two-day old **Faith and Power Pac** in Jacksonville, NC. This contribution, according to **Exhibit 3**, signed by Mr. Patterson, as the Treasurer of **Faith and Power Pac**, certified the PAC's 'Independent Expenditures' had disbursed or obligated \$2.428,265.81 million for producing ads, placing ads, printing and mailing mailers, and making phone calls for the "Federal Candidate <u>supported or opposed</u> by the expenditure." Patterson certified the Federal Candidate: "Erica Danette Smith."

6.At all times, on information and belief, Patterson and others associated with him in this common scheme knew, when he filed these FEC forms, that the \$2.4 million dollar contribution was in full support of Sen. Thom Tillis' re-election.

7.Patterson signed FEC form, incorporated herein as Exhibit 5, certifying he had disbursed \$250,011.88 million to a Florida business, **Neylan & Partners**, on Valentine's Day, 2020 to produce and air tv ads to 'support' 'Federal Candidate' Erica Danette Smith for the U.S. Senate. Patterson certified the \$2.5 million he had received from Warrenton, to his Jacksonville address, was forwarded on to Naples, FL to produce and air tv ads and buy print and post mass mailers to "oppose" Cal Cunningham, Erica Smith's main competitor in the Democratic Primary to be Sen. Tillis's opponent. Patterson certified that Faith and Power Pac Faith...PAC had spent \$2.678,277.69 million to support Ms. Smith, and \$2.928,289.56 to oppose Mr. Cunningham.

8.Patterson, as shown in Exhibit 5, "under penalty of perjury [certified] the independent expenditures reported herein were not made in cooperation, consultation, or concert with, or at the request or suggestion of any candidate or authorized committee or agent of either, or (if the reporting entity is not a political party committee, any political party committee or its agent. Patterson knew, when he signed this FEC form, the **Senate Leadership Fund** was intentionally using him and his North Carolina address as an unethical, possibly illegal, cover for a major "political party committee" engaging in old Jim Crow race-based wedge tricks, to create confusion between Black and White voters, to destroy years of NC NAACP and our partners' work to build Back-White alliances, friendships and fusion electorates!

9.Faith and Power Pac, its mysterious treasurer, Mr. Patterson, and those acting in concert with him, knowingly and falsely reported to the FEC that they made 'independent expenditures' in 'support' of a NC Black woman political leader, minister of God, and an engineer, Ms. Erica Smith, and also spent considerable sums of money (perhaps the same money!) to oppose her white competitor in the Democratic primary. Faith and Power Pac reported expenditures of over \$2.7 million by February 19, 2020 to make tv ads and slick mailers, to intentionally confuse Democratic voters, implying Ms. Smith accepted funds from Republicans—a fatal accusation for any Black candidate in the south. The two leading Democratic competitors were forced to respond to rebut the mysterious group's wedge ads, rather than helping the voters decide on the best candidate to challenge the incumbent.

10. The NC NAACP is sick and tired of these dirty tricks and respectfully request this complaint be given to your best investigators who recognize immediately these historical tricks of race-based character assassinations of experienced, well-educated African American leaders who seek electoral office. We need every wise Black voice possible to during this transformative period for American democracy. Exposing this scam and holding its architects accountable will help to reassure North Carolinians in this time of moral and health crisis.

Summary: Faith and Power Pac submitted false reports to the FEC. Mr. Patterson, when tracked down, should be deposed by FEC investigators, and all his records should be turned over to you. There is time for you to issue a full report this summer so North Carolina voters will have the full picture. Complainants will insure that race-based wedging schemes are exposed and prevented from interfering with our right to vote for the candidate of our choice.
