Dear Mr. Jordan:

We write as counsel to SMP and Rebecca Lambe, in her official capacity as Treasurer (collectively, "Respondents"), in response to a notification sent by the Federal Election Commission ("FEC" or the "Commission") on June 29, 2020. The notification stated that the complaint ("Complaint") in MUR 7754 indicates Respondents may have violated the Federal Election Campaign Act of 1971, as amended (the "Act"). However, the Complaint makes no such allegation.

The Complaint alleges that "Pacific Atlantic Action Coalition ("PAAC"), Pacific Environmental Coalition ("PEC"), and any person(s) who created, operated, and/or made contributions to or in the name of PAAC or PEC" may have violated the Act.<sup>1</sup> The Complaint only references Respondents in passing as the unwitting recipients of funds from those entities.<sup>2</sup> The Complaint does not allege that Respondents committed a violation of the Act or Commission regulations.<sup>3</sup> Furthermore, the Complaint does not allege facts that, if true, would constitute a violation of the Act or Commission regulations by Respondents.<sup>4</sup>

The Act requires that the Commission find "reason to believe that a person has committed, or is about to commit, a violation" of the Act as a precondition to opening an investigation into the alleged violation.<sup>5</sup> In turn, the Commission may find "reason to believe" only if a

complaint sets forth specific facts, which, if proven true, would constitute a violation of the Act.<sup>6</sup> Unwarranted legal conclusions from asserted facts or mere speculation will not be accepted as true, and they provide no independent basis for investigation.<sup>7</sup>

As this Complaint does not allege that Respondents have violated the Act or Commission regulations and the Complaint does not allege any facts that if true would constitute a violation of the Act by Respondents, the Commission must dismiss the Complaint as to Respondents and the Commission should immediately close the file.
