Find reason to believe that William Figlesthaler for Congress and Steven Martin in his official capacity as treasurer failed to report disbursements to Matthew Hurley made through payments to Landslyde Media Group, LLC, and Southeastern Strategies LLC in violation of 52 U.S.C. § 30104(b)(6) and 11 C.F.R. § 104.3(b).
 - b. Take no action at this time regarding the allegation that William Figlesthaler for Congress and Steven Martin in his official capacity as treasurer failed to report disbursements to Matthew Hurley made through Figlsthaler's medical practice in violation of 52 U.S.C. § 30104(b)(6) and 11 C.F.R. § 104.3(b).
 - c. Take no action at this time as to William M. Figlesthaler, Matthew Hurley, Collin Osborne, Rachel Schaaf, Landslyde Media Group, LLC, and Southeastern Strategies LLC.
 - d. Approve the appropriate portions of the Factual and Legal Analysis for William Figlesthaler for Congress and Steve Martin in his official capacity as treasurer, as recommended in the First General Counsel's Report dated June 17, 2021.

b. Approve the associated Factual and Legal Analyses, as recommended in the First General Counsel's Report dated June 17, 2021.


