Dear Ms. Ross:

We write on behalf of Friends of Andrew Yang and Zach Graumann in his official capacity as treasurer (collectively referred to as “FOAY”) in response to the complaint filed by Jack Clifford Lane on August 11, 2020 (the “Complaint”). The Complaint alleges that FOAY violated Federal Election Commission (“FEC” or the “Commission”) regulations by failing to refund contributions that Mr. Lane made for the general election once Mr. Yang terminated his campaign. These allegations are entirely without merit—FOAY has actually made repeated attempts to refund Mr. Lane’s general election contributions (which included an amount in excess of the applicable \$2,800 limit). Accordingly, the Commission should find no reason to believe that FOAY violated the Federal Election Campaign Act of 1971, as amended, or the Commission’s regulations, and it should dismiss the Complaint and close the file.

Campaign committees such as FOAY generally have 60 days to return (or to seek redesignation or reattribution for) an excessive contribution.¹ This rule applies both to contributions in excess of the limits for an election, and to general election contributions where the candidate in question does not win the primary. Here, Mr. Lane made a total of 17 contributions to FOAY during the course of 2019. A table of these contributions is attached to this response as Exhibit A. First, Mr. Lane made a total of 11 primary election contributions to FOAY, for an aggregate primary election contribution of \$2,800, which is within applicable limits.

Second, Mr. Lane contributed \$409.60 to FOAY for the general election on September 20, 2019. This was followed by a contribution of \$2,800 for the general election on October 27, 2019. This resulted in an excessive contribution of \$409.60—recognizing this, FOAY acted promptly, and sent Mr. Lane a refund check for that amount within 3 days, on November 1, 2019. This is well within the 60 day window described above. A copy of this first refund check is attached as Exhibit B.

Third, Mr. Lane made a series of additional general election contributions in November and December 2019. The total amount of contributions at issue is \$581.34. At the time, the first refund check was still outstanding, and thus FOAY waited to send out an additional check until it could confirm the proper amount of refund due to Mr. Lane. On January 1, 2019, FOAY determined to send Mr. Lane a second refund check, refunding the full amount of his general election contribution less the \$409.60 covered by the first check (and notwithstanding the fact that Mr. Yang had yet to withdraw from the race). This second refund check, which was in the amount of \$3,381.34, is attached as Exhibit C. Again, the refund check was issued well within the 60 day window for returning excessive contributions. Mr. Yang ultimately terminated his candidacy for President on February 11, 2020.

Mr. Lane never cashed the first and second refund checks. Accordingly, after waiting for an appropriate period of time, on May 5, 2020 FOAY issued a third refund check in the amount of \$3,790.94 (representing the aggregate of the first and second refund checks), covering the entire amount of contributions at issue. The third refund check is attached as Exhibit D.

To date, Mr. Lane has not cashed the third refund check. Accordingly, following the receipt of the Complaint, FOAY issued yet another refund check in the amount of \$3,790.94.

As this record shows, FOAY has consistently and repeatedly attempted to refund all general election and excessive contributions made by Mr. Lane. The campaign has done so promptly, well within the applicable 60 day time limit, and as quickly as three days after receiving the contribution at issue. When Mr. Lane failed to cash these initial refund checks, FOAY followed up with additional attempts to refund the contributions at issue. As such, the Complaint does not provide any basis for a reason to believe that FOAY violated the Act. We therefore respectfully request that the Commission dismiss this matter and close the file.


