Dear Commission,

I am filing this complaint to the Commission regarding Duane J. Whitmer, a candidate for the NY 27 congressional District special election.

I received two (2) pieces in my mail for the special election in NY 27 before the June 23, 2020 vote allegedly from Whitmer.

Neither of Mr. Whitmer's mailings had any disclosure on them as to who paid for the mailings and whether these mailings were approved by Mr. Whitmer.

There are no disclosures whatsoever and clearly violate the rules and regulations of the FEC regarding disclosures on mailed materials.

I am enclosing copies, both front and back of his postcard mailing and the letter received during the same week in June, 2020.

I ask this commission to investigate any and all activities by Duane J. Whitmer during this special election cycle in NY27, to include violations made in the 2 mailings sent out in June, 2020.

I ask the commission to penalize him as it sees fit for these repeat FEC violations.

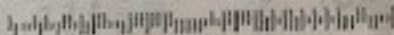
