I write in response to the complaint dated August 18, 2020.

Enclosed are designations from Mr. Whitmer and Ms. Auman.

First, I want to point out that Ms. Auman was not involved in the mailings complained of and we are in the process of filing a change of treasurers. She should be dismissed from the proceeding.

With respect to the mailings complained of, while no disclaimer was supplied, the mailings did refer to the campaign website, duanewhitmer.com, which *does* contain the required disclaimer. Thus, no intent to confuse or actual confusion is present here.

Today, I met with the three persons responsible for sending out communications, Mr. Whitmer and two staffers. We reviewed the FEC rules on disclaimers to ensure that all future mailings and communications contain the required disclaimers. I provided a copy of the FEC manual for Congressional candidates.

As there is no evidence of intent to confuse, curative action has been taken and because this is Mr. Whitmer's first run for office, we would ask that the complaint be dismissed at this time.
