Dear FEC General Counsel:

In reviewing FEC public records on individual contributions during this election cycle, it came to my attention that the Republican National Committee (FEC ID-C00003418), Donald J. Trump for President, Inc., (FEC ID-C00580100) and Trump Make America Great Again Committee (FEC ID-C00618371) reported my name and address as making individual contributions to their committees. Let me assure you, I have not made any of the contributions that were reported by these three committees.

As a point of reference, I have contributed to Act Blue (FEC ID-C00401224) over the years. In reviewing the data on the FEC website, I noticed that Trump Make America Great Again Committee used my exact personal information that was reported by Act Blue—including my business name. I cannot help but think that Trump Make America Great Again Committee may have used my contact information using Act Blue's filed data to report contributions from someone else.

I realize this is a small amount of money, but I wonder if these committees have used other contributor data to disclose contributions in the name of another. I have attached screenshots of the questionably reported transactions that I found on the FEC website.

I have sent the National Republican Committee, Donald J. Trump for President, Inc., and Trump Make America Great Again Committee each a letter requesting that my name be removed from the relevant FEC 3X reports since none of these contributions are from me.


