RE: MUR 7791 – Response of Koch Industries, Inc. Political Action Committee ("KOCHPAC") and Lacye R. Tennille, in her official capacity as Treasurer

Dear Mr. Jordan,

This letter responds to the complaint outlined in MUR 7791 against KOCHPAC and Ms. Tennille, in her official capacity as treasurer. Based on the attached documents, we respectfully request that this complaint be dismissed.

- First, as demonstrated by the attached documents, KOCHPAC and Ms. Tennille, in her official capacity as treasurer, did not exceed any federal campaign finance contribution limits. KOCHPAC and Ms. Tennille reported all contributions accurately on the relevant monthly FEC reports. KOCHPAC's transmittal letters and checks identified the payees clearly for the 2019 and 2020 contributions to First Capital PAC and the 2020 primary and general election contributions to Patriots for Perry (Attachments 2 - 8).
- Second, on September 21, 2020, KOCHPAC received First Capital PAC's refund of the 2019 leadership PAC contribution (\$5,000) that Patriots for Perry mistakenly deposited in December 2019, and then recently transferred to the leadership PAC. A copy of the refunded check is attached (Attachment 1), and the confirmation of the refund deposition is included (Attachment 1B).

¹ On September 11, 2020, KOCHPAC and Ms. Tennille, in her official capacity as treasurer, received notice from the Federal Election Commission ("FEC") that Mr. Daniel Caruso of Mechanicsburg, PA had filed a complaint alleging that the following entities accepted and/or made excessive contributions and made false statements on their campaign finance reports:

[•] Congressman Scott Perry's candidate campaign committee (Patriots for Perry), his leadership PAC (First Capital PAC), these committees' treasurer, Lisa Stone, in her official capacity, and KOCHPAC, and Ms. Tennille, in her official capacity as treasurer of KOCHPAC.

On November 19, 2019, KOCHPAC contributed \$5,000 for the 2020 primary election to Patriots for Perry.² The check's payee was clearly marked as Patriots for Perry, and the memo line stated "2020 primary" (Attachment 2). The transmittal letter also clearly identified the payee as Patriots for Perry (Attachment 2). It was mailed on November 21, 2019 and cleared the bank on November 26, 2019 (Attachment 3). KOCHPAC reported this contribution to Patriots for Perry on its December 2019 monthly report.³

On December 9, 2019, KOCHPAC contributed \$5,000 to First Capital PAC.⁴ This check was sent by courier on December 17, 2019 and cleared the bank on December 26, 2020 (Attachment 4). Both the check and transmittal letter clearly identified the payee as "First Capital PAC," and the memo line stated "2019 contribution" (Attachment 5). KOCHPAC reported this contribution to First Capital PAC on its 2019 year-end report.⁵

On June 22, 2020, KOCHPAC contributed \$5,000 for the 2020 general election to Patriots for Perry. The check's payee was clearly marked as Patriots for Perry, and the memo line stated "2020 general" (Attachment 6). The transmittal letter also clearly identified the payee as Patriots for Perry (Attachment 6). This check was sent via FedEx on June 29, 2020 and cleared the bank on July 7, 2020 (Attachment 7). KOCHPAC reported this contribution to Patriots for Perry on its July 2020 monthly report.⁶

On June 22, 2020, KOCHPAC contributed \$5,000 to First Capital PAC, Congressman Perry's leadership PAC. This check was sent via FedEx on June 29, 2020 and cleared the bank on July 8, 2020 (Attachment 7). Both the check and the transmittal letter clearly identified the payee as "First Capital PAC," and the memo line stated "2020 contribution" (Attachment 8). KOCHPAC reported this contribution to First Capital PAC on its July 2020 monthly report.






If you tell us orally, we may require that you send us your complaint or question in writing within 10 business days.

We will tell you the results of our investigation within 10 business days after we hear from you and will correct any error promptly. If we need more time, however, we may take up to 45 days to investigate your complaint or question. If we decide to do this, we will recredit your account within 10 business days for the amount you hink is in error, so that you will have the use of the money during the time it takes us to complete our investigation. If we ask you to put your complaint or question in writing and we do not receive it within 10 business days, we may not recredit your account.


For errors involving new accounts (within 30 days after the first deposit), point of sale transactions made with an INTRUST ATM Card, INTRUST Visa® Debit Card, INTRUST HSA Visa Debit Card, INTRUST Wealth Checking Visa Debit Card, or foreign-initiated transactions, we may take up to 90 days to investigate your complaint or question. For new accounts, we may take up to 20 business days to credit your account for the amount you think is in error.





Account Transactions by type with detailed description









