24 25	On De	ecember 2, 2021, the Commission found reason to believe that Buzz Patterson for
26		Louis Baglietto in his official capacity as treasurer (the "Committee") violated
27	•	0104(a), (b) and 11 C.F.R. § $104.3(a)$, (b) by failing to file required reports of
28		lisbursements. ¹ The Commission authorized compulsory process and approved an
29	investigation. ² During the investigation, Baglietto was named and notified as a respondent in his	
30	personal capacity. ³ After the investigation was completed, on January 26, 2023, the Commission	
31	found reason to believe that Baglietto in his personal capacity violated 52 U.S.C. §§ 30102(c),	
32		I(a), (b) and 11 C.F.R. §§ 102.9 and 104.3(a), (b) by failing to keep complete
33		ile reports with the Commission. ⁴ The Commission authorized the Office of
34		usel ("OGC") to engage in pre-probable cause conciliation and approved separate

conciliation agreements with the Committee and Baglietto.⁵ Attached are the two negotiated
