**CONSENT TO EXTEND THE TIME
TO INSTITUTE A CIVIL LAW ENFORCEMENT SUIT**

In exchange for an additional sixty (60) days to respond to the Complaint in this matter, Respondent Peter Gagliano hereby consents to toll the statute of limitations as specified below for a period of sixty (60) days for any civil enforcement suit that the Federal Election Commission might institute pursuant to 52 U.S.C. § 30109(a)(6) in connection with any actions of Respondent specified in the Complaint. This agreement will extend the time to institute a civil law enforcement suit from the expiration date of the five-year statute of limitations found at 28 U.S.C. § 2462, or any other statute of limitations or repose that may be applicable in this matter, for a period of sixty (60) days for any activity for which the applicable statute of limitations had not already run as of the due date for the response to the Complaint in MUR 7801, as calculated pursuant to 52 U.S.C. § 30109(a)(1).

There shall be no additional consent to extend the time to institute a civil law enforcement suit without the written consent of the Respondent.
