COMPLAINT

This complaint is filed with the Federal Election Commission (“FEC” or “Commission”) pursuant to 52 U.S.C. § 30109(a)(1) and is based on information providing reason to believe that Abby Broyles for U.S. Senate (ID: C00580100) (the “Broyles Campaign”) has violated the reporting requirements of the Federal Election Campaign Act, 52 U.S.C. § 30101, *et seq.* (the “Act”).

The Broyles Campaign violated the Act by soliciting and accepting corporate contributions from an Oklahoma City-based television station in violation of the federal law prohibition against soliciting and accepting corporate funds as well as not disclosing all in-kind contributions made and accepted.

Complainant, the Oklahoma Republican Party, is a state political party in Oklahoma.

FACTS

1. Abby Broyles is a candidate for the United States Senate. Abby Broyles for U.S. Senate (ID: C00580100) is her authorized campaign committee. Abby Broyles for U.S. Senate registered with the FEC on November 4, 2019.

2. KFOR-TV (“KFOR”), virtual channel 4 (UHF digital channel 27) is an NBC-affiliated television station licensed in Oklahoma City, Oklahoma.¹ KFOR is owned by the Nexstar Media Group. *Id.*
3. Prior to running for U.S. Senate, Abby Broyles was employed as a reporter for KFOR for several years.²
4. KFOR is a broadcast licensee that has sold commercial airtime to the Abby Broyles for U.S. Senate Campaign during the 2020 campaign cycle.
5. KFOR has also aired paid campaign advertisements from the Friends for Jim Inhofe Campaign (the “Inhofe Campaign”) (ID: C00207993) during the 2020 campaign cycle.
6. However, KFOR has been consistently charging the Broyles Campaign less than it has charged the Inhofe Campaign, despite the statutory requirement that broadcast licensees charge legally qualified candidates who use their services in connection with their campaigns no more than the lowest unit charge for the same class within the political window, which begins sixty (60) days prior to a general election. 47 U.S.C. § 315(b)(1); 47 CFR § 73.1942(a)(1).
7. For example, during the week of September 14, 2020, KFOR charged the Broyles and Inhofe Campaigns the following rates³ for the following timeslots:

8. The Broyles Campaign spent a total of \$69,920.00 on KFOR advertising between the dates of September 9-27, 2020. *See Ex. A.* If the Broyles Campaign had been charged at the same rate as the Inhofe Campaign, it would have spent thousands of dollars more for the same number of spots and airtime it purchased. *See Ex. B.*
9. The Broyles Campaign has benefited from thousands of dollars of in-kind corporate contributions in the form of subsidized ad buys, in violation of the Act.
10. Upon information and belief, it is our understanding that the Broyles Campaign solicited KFOR to receive a discounted rate for advertising based on Abby Broyles' relationship as a former employee at KFOR.
11. Further, the Broyles Campaign has failed to report these in-kind corporate contributions, in direct violation of the Act.
12. "If the Commission, upon receiving a complaint . . . has reason to believe that a person has committed, or is about to commit, a violation of [the Act] . . . [t]he Commission *shall* make an investigation of such alleged violation . . ." 52 U.S.C. § 30109(a)(2) (emphasis added); *see also* 11 C.F.R. § 111.4(a).

SUMMARY OF THE LAW

13. The Broyles Campaign has knowingly and willfully violated 52 U.S.C. § 30125(e)(1)(A) and 52 U.S.C. § 30116(a)(1) which prohibits candidate committees from soliciting and accepting contributions from a union or corporate funds, *id.* § 30118(a) and (b)(2), and its requirement that candidate committees and non-connected political committees report and disclose all in-kind contributions made and accepted, *id.* § 30104(b) (requiring reporting of “contributions” and “expenditures” by political committees).
14. Federal candidates are prohibited from soliciting, receiving, transferring, disbursing, or otherwise spending funds in connection with any election unless those funds are subject to the Federal Election Campaign Act’s limitations, prohibitions, and reporting requirements. 52 U.S.C. § 30125(e)(1)(A).
15. The term “solicit” is defined in the Act to mean “to ask, request, or recommend, explicitly or implicitly, that another person make a contribution, donation, transfer of funds, or otherwise provide anything of value” and it “may be made directly or indirectly.” 11 C.F.R. § 300.2(m).
16. The term “contribution” is defined in the Act to mean “any gift, subscription, loan, advance or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office.” 52 U.S.C. § 30101(8)(A)(i).
17. As used in the definition of “contribution,” the phrase “anything of value” includes “all in-kind contributions.” The “provision of any goods or services without charge or at a charge that is less than the usual and normal charge for such goods or services is a contribution.” 11 C.F.R. § 100.52(d)(1). Under these circumstances, the difference between the usual and

normal fair market price paid by the Inhofe Campaign and the discounted price paid by the Broyles Campaign is considered an in-kind contribution. *Id.*

18. The authorized committee of a candidate for federal office must report to the Commission the identification of each person who makes a contribution to the committee with an aggregate value in excess of \$200 within an election cycle. 52 U.S.C. § 30104(b)(3)(A).
19. Corporations and labor organizations may not make contributions to federal candidates, and federal candidates may not accept contributions from corporations or labor organizations. 52 U.S.C. § 30118(a).

VIOLATIONS OF THE ACT

20. The Broyles Campaign violated the Act by soliciting an in-kind contribution from a corporation. 52 U.S.C. § 30125(e)(1)(A).
21. The Broyles Campaign violated the Act by accepting an in-kind contribution in the form of a good or service for “less than the usual and normal charge for such good or service” from a corporation or labor union. *See* 11 C.F.R. § 100.52(d)(1); 52 U.S.C. § 30118(a).
22. The Broyles Campaign violated the Act by failing to report all in-kind contributions made and accepted. 52 U.S.C. § 30104(b).

PRAYER FOR RELIEF

23. Wherefore, the Commission should find reason to believe that Abby Broyles for U.S. Senate violated the Act and conduct an immediate investigation under 52 U.S.C. § 30109(a)(2). Further, the Commission should determine and impose appropriate sanctions for any and all violations, should enjoin the Broyles Campaign from any and all violations in the future, and should impose such additional remedies as are necessary and appropriate to ensure compliance with the Act.

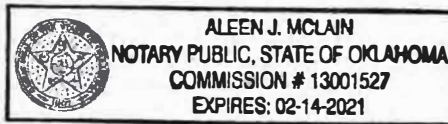
