Dear Mr. Jordan and Ms. Ross:

This office represents DTE Energy Company and DTE Corporate Services, LLC, in response to the complaint (the "Complaint") filed by the Campaign Legal Center. The Statement of Designation of Counsel Form is attached.

The Commission's November 4, 2020 letter notifying us of the Complaint was received on November 24, 2020. Accordingly, a Response would ordinarily be due on Wednesday, December 9, 2020. We are requesting an initial extension of 30 days within which to file our Response. If this extension is granted, our Response would be due on Friday, January 8, 2021.

Based on the nature of this matter, it will be necessary to review numerous records in order to allow us to make certain representations to the Commission; however, because we are now in the Holiday season, and the extra challenges presented by the COVID-19 pandemic since personnel are now working remotely with less access to records, this is simply going to take more time. This matter also raises important legal issues under the Federal Election Campaign Act. For these reasons, as well as counsel's scheduling constraints, we submit that a 30-day extension is necessary and reasonable.

Thank you for your consideration of this request. Please let us know whether the proposed deadline is acceptable.
