Dear Mr. Jordan:

On behalf of the Center for Tech and Civic Life (“CTCL”), Tiana Epps-Johnson, and Whitney May (together, the “CTCL Respondents”), this responds to a complaint filed with the Federal Election Commission (“FEC” or the “Commission”) by Jay Stone (the “Complainant”) in the above-referenced matter (the “Complaint”). Because the Complaint fails to set forth facts alleging any violation of the Act or the Commission’s regulations and is a series of baseless claims, the Commission should dismiss the Complaint and take no further action against the CTCL Respondents in this matter.

I. INTRODUCTION

The Complaint appears to allege that the CTCL Respondents violated the Federal Election Campaign Act of 1971, as amended, 52 U.S.C. § 30101, *et seq.* (“FECA” or the “Act”) when CTCL made grants to state and local government agencies for use in election administration for the 2020 elections.¹ The Complaint also alleges that others, including the Center for Election Innovation and Research, its Executive Director David Becker, Mark

Zuckerberg and Priscilla Chan also violated the Act. This response addresses the Complaint only with respect to the CTCL Respondents.

A. The CTCL Respondents

CTCL, established in 2014, is a nonpartisan, nonprofit, charitable and educational organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code. Its purpose is to promote civic engagement by modernizing election administration and engagement between local governments and the people they serve. CTCL “connects Americans with the information they need to become and remain civically engaged, and helps ensure elections are professional, inclusive, and secure.”² In service to its mission, it collects, standardizes and makes available to the public information about elections, and routinely conducts in-person and on-line trainings for election officials to help them best serve their communities.³ CTCL also makes grants to state and local election offices to support election administration.⁴

CTCL is governed by a bipartisan Board of Directors and its Advisory Committee is comprised primarily of individuals, including election administrators, with broad expertise in election administration.⁵ CTCL is staffed by “a team of civic technologists, trainers, researchers, election administration and data experts working to foster a more informed and engaged democracy, and helping to modernize U.S. elections.”⁶ Respondent Tiana Epps-Johnson, a CTCL Founder and its Executive Director, has deep expertise in election administration and voting rights.⁷ Respondent Whitney May, another CTCL Founder and its Director of Government Services, is a former county election administrator and has extensive experience working with election administrators around the country.⁸

B. CTCL’s COVID-19 Response Grant Program

In 2020, in furtherance of its charitable and educational purposes, CTCL created a COVID-19 Response Grant Program (the “Grant Program”) to help state and local governments address the unprecedented challenges to election administration posed by the ongoing global pandemic. Grants were made available on a nonpartisan, non-discriminatory basis to any U.S. election office responsible for administering election activities and which chose to apply for a grant.⁹ Every such applicant was guaranteed a grant of at least \$5,000.¹⁰ No state or local election administration office that applied for a grant for funding consistent with the Grant Program received less funding than it requested.

The Grant Program made a limited number of grants in the weeks preceding its open call for grant applications and before its online application was fully operational. For example, in early July, the Grant Program awarded funds to Wisconsin’s five largest cities to help them implement their Wisconsin Safe Voting Plan 2020 in the August 11 primary elections and the November 3 general election.¹¹ The Wisconsin Safe Voting Plan 2020 was a collaboration among those cities to:

safely administer elections to reduce the risk of exposure to coronavirus for [their] residents as well [their] election officials and poll workers; identify best practices, innovate to efficiently and effectively educate [their] residents about how to exercise their right to vote; be intentional and strategic in reaching [their] historically disenfranchised residents and communities; and above all, ensure the right to vote in [their] dense and diverse communities.¹²

All grants, including these early grants, were awarded on a nonpartisan basis through procedures that were wholly consistent with CTCL’s tax-exempt status and its mission. In the end, the Grant Program made grants to more than 2,500 state and local government entities to ensure those entities were able to “cover expenses like personal protective equipment, additional election worker recruitment and training, and absentee voting equipment and supplies.”¹³ (A list of the jurisdictions to which the Grant Program has awarded grants is included herewith as “Exhibit A,” and is publicly available on CTCL’s website at <https://www.techandciviclelife.org/grant-awards/>.¹⁴) Grants were made to rural, suburban and urban communities and in at least 47 states and the District of Columbia.¹⁵

II. LEGAL ANALYSIS

The Complaint must be dismissed because it fails to set forth facts that, even if true, would amount to a violation of the Act or the Commission’s regulations, and because the allegations in the Complaint are baseless and unsupported by fact.

A. The Complaint Must Be Dismissed Because It Sets Forth No Facts Alleging a Violation of the Act or the FEC’s Regulations.

The Complaint fails to provide reason to believe that any of the CTCL Respondents violated the law. In order to support a reason to believe finding, a complaint must “contain a clear and concise recitation of the facts which describe a violation of a statute or regulation over

which the Commission has jurisdiction.¹⁶ The Complaint does not. Its allegations are that CTCL's Grant Program was administered on a partisan basis and awarded grants only to "Democratic strongholds"¹⁷ and were, therefore, contributions to the presidential campaign of Vice President Joseph R. Biden, Jr. (the "Biden Campaign").¹⁸ With respect to Ms. Epps-Johnson and Ms. May, the Complaint is entirely unclear as to how either of them are alleged to have violated the law. A generous reading of the Complaint may imply either that their partisan posts on their own individual social media accounts are unlawful, or that those posts somehow convert CTCL's grants into contributions to the Biden Campaign.¹⁹

Even if the information posited by Complainant was true, and the Grant Program awarded funds to state and local governments based on partisan considerations (which it did not), or Respondents Epps-Johnson's and May's personal social media posts had any relevance to the Grant Program (which they do not), none of these amount to a violation of FECA or the Commission's regulations. Notably, the Complaint acknowledges that the Grant Program awards went directly to government agencies and does not allege or point to any facts indicating that the grants were made directly to the Biden Campaign (which they were not), or that the grants were payments for services rendered or goods provided to the Biden Campaign (which they were not). Nor does the Complaint allege or set forth any facts stating that the grants were made in coordination in the Biden Campaign (which they were not) and therefore resulted in an in-kind contribution under the Commission's coordination regulations. The Complaint simply fails to set out any facts that would render any CTCL grant a "contribution" under the Act or the Commission's regulations even if the grants had been made only to "Democratic strongholds."²⁰ (In fact, they were not.)

Further, the Commission's regulations exempt volunteer internet activity from treatment as either a contribution or an expenditure under the Act.²¹ Neither Ms. Epps-Johnson nor Ms. May are compensated by CTCL to post personal views on their individual social media accounts and when they engage in such activity, they do so on their own behalf and not on behalf of CTCL (which has its own social media accounts). The Complaint does not allege otherwise. It simply does not set forth any facts to establish that Ms. Epps-Johnson's or Ms. May's social media posts are unlawful or that their personal views had any bearing on the Grant Program. Indeed, in Matter Under Review ("MUR") 5684, the Commission found no reason to believe that Citizen Change, a 501(c)(3) organization engaged in nonpartisan voter drive efforts, violated FECA or the Commission's regulations when celebrity participants expressed their personal partisan opinions at the organization's rallies.²² Here, it is not even alleged that Ms. Epps-Johnson or Ms. May made partisan statements while engaged in activity on behalf of CTCL or on CTCL's social media accounts. Rather, it is alleged only that they did so *in their own names on their own, personal social media accounts unrelated to CTCL or the Grant Program*. As in MUR 5684, the expression of these personal opinions cannot and does not convert a 501(c)(3)'s

nonpartisan activity into partisan activity that violates FECA.

“The Commission may only find ‘reason to believe’ if a complaint sets forth sufficient specific facts, which, if proven true, would constitute a violation of the FECA.”²³ “Unwarranted legal conclusions from asserted fact ... or mere speculation ... will not be accepted as true.”²⁴ The Complaint falls entirely short of this standard. Because the Complaint does not provide sufficient facts to support a reason to believe finding, and instead relies on mere speculation and unwarranted legal conclusions, the Commission should dismiss this Complaint.

B. The Complaint Must Be Dismissed Because It Is Factually Baseless.

The Complaint’s central allegation regarding the Grant Program is that its grants were awarded “only to Democratic strongholds” based on partisan considerations and with the purpose of supporting the Biden Campaign.²⁵ This claim is false and entirely contravened by the facts in this matter.

Grants were not awarded solely to Democratic strongholds. Grant applications were open to any U.S. election office responsible for administering election activities and grants were awarded to every such office that applied for a grant.²⁶ As is clear from the list of more than 2,500 jurisdictions receiving awards from the Grant Program contained in Exhibit A, many jurisdictions whose electorates traditionally vote Republican and were expected to vote Republican in the 2020 presidential election received awards from the Grant Program. For example, all 77 counties in Oklahoma voted for Donald J. Trump in the 2016 Presidential Election.²⁷ In 2020, 42 of those counties applied for grants from CTCL’s Grant Program and each of those counties was awarded a grant under CTCL’s Grant Program.²⁸ A review of the Grant Program’s awardees listed in Exhibit A makes it readily apparent that grant awards were not limited to “Democratic strongholds,” a fact supported by the record in court cases throughout the country addressing the Grant Program:

- “In Pennsylvania, as of October 5, 2020, CTCL has awarded grants to eighteen counties and the Pennsylvania Department of State. Eleven of these eighteen counties voted for Donald Trump over Hillary Clinton in the 2016 presidential election, and five did so by more than a two-to-one margin.”²⁹
- “Over 1,100 jurisdictions have applied so far, in almost every U.S. state, with most applicants serving jurisdictions with fewer than 25,000 registered voters. For example, in

Minnesota, CTCL has awarded grants not just to Minneapolis, but to at least 21 other jurisdictions including, Albertville, in Wright County; Becker, in Sherburne County; and Watertown, in Carver County.”³⁰

- In a hearing relating to whether a temporary restraining order (TRO) should be issued to prevent Texas counties from accepting funds from the Grant Program, the Court noted “Hopkins County applied for a grant and there is no way you can convince this Court that Hopkins County is trying to take that money with the hopes of helping progressive candidates because ... it’s a Republican county, probably a majority Republican county by a wide margin.... And I know that because I’m a former elected judge, so that was one of my counties....”³¹

Partisan criteria were not considered in the Grant Program’s award of grants. The Grant Application (a copy of which is included herewith as “Exhibit B”) did not request information about the partisan make-up of any jurisdiction’s electorate, the outcome of past elections, or other partisan factors, nor did CTCL consider such information. Rather, every state and local government office responsible for administering elections was guaranteed a grant of at least \$5,000.³² Beyond the base grants available to every election office, additional funding was awarded to jurisdictions that faced, for example, extraordinary pandemic-related election administration challenges such as excessive wait times or lack of poll workers or unexpected large capital needs such as ballot handling equipment or space for safe, distanced voting. These are legitimate nonpartisan considerations, and there is simply no factual support for Complainant’s assumption that grants were made on some other basis.

In recent months, a number of courts have examined allegations similar to Complainant’s that the Grant Program’s awards were partisan in nature. Each of these courts has rejected these spurious claims, finding, for example, that election administrators in Pennsylvania “have used CTCL funding in a nonpartisan way to facilitate the upcoming election,”³³ that “CTCL grants are nonpartisan and guaranteed to any municipality that meets minimum criteria,”³⁴ and that the allegation that CTCL targeted its grants to “progressive cities” was “contradict[ed]” by the data and “unsupported” by fact.³⁵

CTCL applied objective, nonpartisan criteria to review and identify grant recipients. Because the central premise of the Complaint is without any factual basis and instead relies on

“mere speculation,” the Commission should dismiss the Complaint.³⁶

Conclusion

Because the Complaint does not set forth facts alleging a violation of the Act or the Commission’s regulations and is without factual basis, the CTCL Respondents respectfully request that the Commission dismiss the Complaint and take no further action in this matter.
