- 2. On January 22, 2021, Michael Joseph Gaul, 4004 Rosedale Place, Grovetown, GA 30813, under name, "Patriot Party", filed a Form 1 (Statement of Organization) FEC No. 1489852, listing Donald J Trump for President (DJTFP) as a participant in purported joint fundraising activities under 11 C.F.R. 102.17.
- 3. Apparently, Michael Joseph Gaul, 4004 Rosedale Place, Grovetown, GA 30813 formed a committee named, 'Patriot Party', and petitioned/obtained FEC ID No. C00767095) on behalf of said 'Patriot Party' nomenclature to facilitate filing of Filing FEC No. 1489852 on January 22, 2020 without knowledge nor permission of Affiant, Dr. Joseph A. Resnick nor former President Donald J. Trump.
- 4. On 1/25/2020 DJTFP filed Form FEC 99 Stating:

Donald J. Trump for President, Inc. ('DJTFP') is filing this miscellaneous report under 11 C.F.R. 102.13 and 100.3(a)(3) to disavow the activities of a committee named Patriot Party (FEC ID No. C00767095), whose listed Treasurer is Michael Joseph Gaul, 4004 Rosedale Place, Grovetown, GA 30813. On January 22, 2021, Patriot Party filed a Form 1 (Statement of Organization) listing DJTFP as a participant in purported joint fundraising activities under 11 C.F.R. 102.17. DJTFP did not authorize the filing of this Form 1, has not entered into any joint fundraising agreement to fundraise through Patriot Party, and has no knowledge of Patriot Party's activities whatsoever. To be clear: DJTFP has no affiliation with Patriot Party, which is not authorized by Mr. Trump or DJTFP. DJTFP is placing this disavowal notice on the public record out of concern for confusion among the public, which may be misled to believe that Patriot

Party's activities have been authorized by Mr. Trump or DJTFP -- or that contributions to this unauthorized committee are being made to DJTFP -- when that is not true. Copy herewith attached.

Further, according to a filing, FEC #1489852 dated 1/22/2021, you used the name, "Patriot Party", in said filing without my knowledge nor permission and in absence of any right or valid License Agreement to my Intellectual Property. This could constitute the tort, 'Fraud', in violation of your purported joint fundraising activities under 11 C.F.R. 102.17 as stated in your filing, FEC #1489852 dated 1/22/2021.

For your information I founded (The) 'Patriot Party' in 2020 before the US Department of the Treasury which issued to me EIN #86-1557893. I claimed Copyright by virtue of that filing, and subsequent filings with various other state and federal agencies and departments, and you did not and do not have my permission to use that name in your apparent fundraising efforts as stated in the FEC #1489852 filing stated above.

I learned today that former President Donald J. Trump issued the following 'Notice' to the FEC, disavowing any affiliation with you or 'The Patriot Party' as shown in the attached FEC document identifier at

URL https://docquery.fec.gov/pdf/667/202101259413340667.pdf. This is very embarrassing to me! Your unauthorized actions, including unauthorized use of the 'Patriot Party' nomenclature, as well as representing affiliation with former President Donald J. Trump in your FEC Form 1 filing (which Mr. Trump has formally disavowed), has potentially implicated me and "The Patriot Party" in what is most probably a fraudulent, dubious filing before the FEC, and has jeopardized the instant and future value of my intellectual property comprising the terms, (The) Patriot Party and 'Patriot Party', constituting a potential Cause of Action.

As a result of your actions the prospect of Mr. Trump, or anyone, ever using the 'Patriot Party' nomenclature has been damaged beyond repair.

Dear Dr. Resnick:

This is in response to your email to the Federal Election Commission (the "Commission"), received on January 28, 2021. The Commission is an independent regulatory agency charged with administering and enforcing the Federal Election Campaign Act of 1971, as amended (the "Act"), and Chapters 95 and 96 of Title 26, United States Code. The Act and Commission regulations require that a complaint meet certain requirements. Your email does not meet these requirements. Specifically, your submission was not sworn to and notarized, as required under the Act. Consequently, the Commission can take no action at this time unless the allegations are refiled meeting the requirements for a properly filed complaint.

Requirements of a legally-sufficient complaint, which are a prerequisite to Commission action, are detailed below:

- (1) A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction. (11 C.F.R. § 111.4).
- (2) Its contents must be sworn to and signed in the presence of a notary public and shall be notarized. (52 U.S.C. § 30109(a)(1)). The notary must indicate as part of the jurat that such swearing occurred. The preferred form is "Subscribed and sworn to before me on this ____ day of ____, 2021."
- (3) A formal complaint should be accompanied by supporting documentation if known and available to the person making the complaint. (11 C.F.R. § 111.4).
- (4) A complaint must be in writing. (52 U.S.C. § 30109(a)(1)). As noted below, during this time, a complaint may be emailed if you are in a state in which electronic notarization is available.
- (5) A formal complaint must contain the full name and address of the person making the complaint. (11 C.F.R. § 111.4).
- (6) A formal complaint should clearly identify as a respondent each person or entity who is alleged to have committed a violation. (11 C.F.R. § 111.4).

This matter will remain confidential for a 15 day period to allow you to correct the defects in your complaint. Any corrections to your complaint must be submitted in writing to the General Counsel at the FEC's street address, or submitted by email to EnfComplaint@fec.gov, if you are in a state in which electronic notarization is permissible.



DJTFP is placing this disavowal notice on the public record out of concern for confusion among the public, which may be misled to believe that Patriot Party's activities have been authorized by Mr. Trump or DJTFP -- or that contributions to this unauthorized committee are being made to DJTFP -- when that is not true.
