This letter is submitted on behalf of Senate Leadership Fund in connection with MURs 7886 and 7890.

On March 22, 2021, we received emailed complaint notifications for Senate Leadership Fund, sent to our firm directly, in MURs 7885 and 7888. We filed responses in those matters on April 7, 2021.
