Dear Mr. Keeys,

This letter is submitted on behalf of Senate Leadership Fund in connection with MURs 7886 and 7890.

On March 22, 2021, we received emailed complaint notifications for Senate Leadership Fund, sent to our firm directly, in MURs 7885 and 7888. We filed responses in those matters on April 7, 2021.

Today, it came to our attention that two additional complaint notifications (in MURs 7886 and 7890) were delivered to our client on March 24, 2021, but that both emails were filtered into a “junk” email folder. These two emails were discovered today and forwarded to our attention.

All four complaints were filed by the same complainant and involve similar matters. Had we been aware of the complaint notifications in MURs 7886 and 7890 on March 24, responses would be due Thursday, April 8. Given the circumstances, we are requesting additional time to respond to MURs 7886 and 7890, and request an extension to Friday, April 16, 2021.
