Dear Mr. Jordan:

We write as counsel to Senator Sheldon Whitehouse and his federal campaign committee, Whitehouse for Senate (the "Committee") (collectively, "Respondents") in response to your notification of a complaint filed with the Federal Election Commission on March 25, 2021 (the "Complaint"). The Complaint alleges that a contribution that the Committee received on March 29, 2017 from Madeline Wachtel was in fact made by Ms. Wachtel's father, William Wachtel. The Complaint does not allege that Senator Whitehouse or the Committee knew of the alleged straw donor arrangement. Before receiving this Complaint, Respondents were not aware of any evidence to suggest that the contribution attributed to Ms. Wachtel was not made from her personal funds.

In February 2017, Senator Whitehouse invited Mr. Wachtel to attend a campaign fundraising event, and Mr. Wachtel responded asking to be connected with a campaign fundraiser because he wanted to raise money for the Senator's reelection campaign. For his volunteer fundraising, the Committee provided Mr. Wachtel with an ActBlue contribution link, https://secure.actblue.com/contribute/page/wachtel. That link requires contributors to attest, among other things, "This contribution is made from my own funds, and funds are not being provided to me by another person or entity for the purpose of making this contribution." A screenshot of this contribution page is attached as Exhibit A.

¹ The Complainant claims: "I met with US Senator Whitehouse at the Capitol along with Wachtel on December 12, 2016, at which point Wachtel offered to assist with fundraising for the senator." Complaint at 4. Senator Whitehouse has no memory of such a meeting, and a review of his official schedule from December 12, 2016 shows no meeting with Mr. Wachtel or the Complainant. Senator Whitehouse does not take fundraising meetings in his official office.

Ms. Wachtel's March 29, 2017 contributions were made through this ActBlue link and therefore accompanied by the attestation. Because the contribution came through Mr. Wachtel's dedicated link, Committee staff thanked Mr. Wachtel for raising the contribution, and Mr. Wachtel responded: "Please tell Sheldon that she is a big fan as works for the Harbor School on Governors Island and helps lead the Billion Oyster Project." It was always Respondents' understanding that the contribution attributed to Ms. Wachtel was made from her personal funds.

Respondents do not accept contributions made in the name of another. Should the Commission determine that that has happened in this case, Respondents are prepared to refund or disgorge the contribution.

We hope that this information is helpful to you in investigating these allegations.
