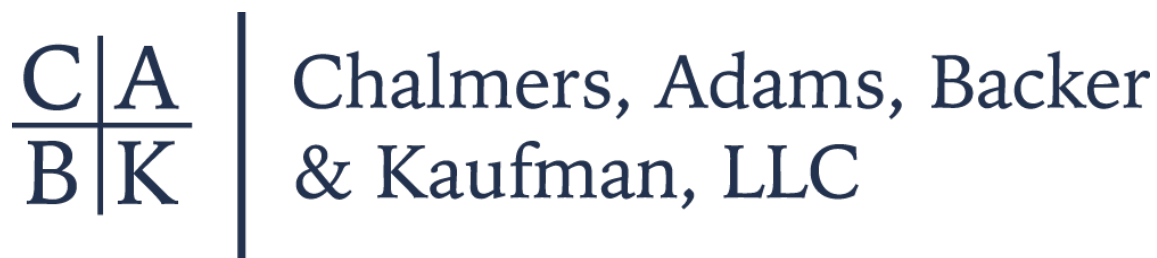
Please find attached a designation of counsel with respect to MUR 7894R.
