- 2. Attached as Exhibit A is a list of employees for which the payroll of those employees were paid for with a combination of federal and non-federal dollars in the month of September 2018. And timecards were regularly collected during my employment.
- 3. It is my recollection that the listed employees did not spend more than 25% of any of those months working on activity directly in connection with a federal election or federal election activities as defined by 52 U.S.C. § 30101(20).
