Dear Mr. Lockett:

Mankato Place 1, LLC (“Mankato Place”), by and through its attorneys, Dorsey & Whitney LLP (“Dorsey”), requests a thirty (30) day extension of time, up to and including September 9, 2021, to respond to the Federal Election Commission’s Complaint, MUR 7913 (“Complaint”).
