Schweikert and Valerie Giramberk in her official capacity as treasurer (the "Schweikert Committee") knowingly and willfully violated 52 U.S.C. § 30104(b)(5) and (b)(6) and 11 C.F.R. § 104.3(b)(3) and (b)(4) by misreporting the purpose of disbursements; (2) the Schweikert Committee knowingly and willfully violated 52 U.S.C. § 30104(b)(5) and (b)(6) by misreporting payees; (3) the Schweikert Committee knowing and willfully violated 52 U.S.C. § 30114(b) and 11 C.F.R. § 113.1(g) by converting campaign funds to personal use; and (4) Richard Oliver Schwab violated 52 U.S.C. § 30102(c)(5) by failing to maintain records. The Commission also authorized the Office of General Counsel to engage in pre-probable cause conciliation with Respondents and approved a separate conciliation agreement for each Respondent.²
