Dear Mr. Passantino:

On September 2, 2021, the Federal Election Commission ("Commission") notified your clients, Herschel Walker and Team Herschel, Inc. and Jason D. Bowles in his official capacity as treasurer, of a complaint alleging violations of certain sections of the Federal Election Campaign Act of 1971, as amended. On August 29, 2022, based on the information provided in the complaint, and information provided by you, the Commission decided to exercise its prosecutorial discretion to dismiss the allegations as to Herschel Walker and Team Herschel, Inc. and Jason D. Bowles in his official capacity as treasurer. The Commission then closed its file in this matter. A copy of the General Counsel's Report, which more fully explains the basis for the Commission's decision, is enclosed.

Documents related to the case will be placed on the public record within 30 days. *See* Statement of Policy Regarding Disclosure of Closed Enforcement and Related Files, 68 Fed. Reg. 70,426 (Dec. 18, 2003) and Statement of Policy Regarding Placing First General Counsel's Reports on the Public Record, 74 Fed. Reg. 66132 (Dec. 14, 2009). - did not raise contributions or make expenditures for any purpose aggregating more than \$5,000
- 2 prior to August 24, 2021.⁴

3 Based on its experience and expertise, the Commission has established an Enforcement 4 Priority System using formal, pre-determined scoring criteria to allocate agency resources and 5 assess whether particular matters warrant further administrative enforcement proceedings. These 6 criteria include (1) the gravity of the alleged violation, taking into account both the type of activity 7 and the amount in violation; (2) the apparent impact the alleged violation may have had on the 8 electoral process; (3) the complexity of the legal issues raised in the matter; and (4) recent trends in 9 potential violations and other developments in the law. This matter is rated as low priority for 10 Commission action after application of these pre-established criteria. Given that low rating, the 11 speculative nature of the allegations, and the fact that the available information does not indicate that the Committee raised contributions or made expenditures aggregating more than \$5,000 prior to 12 13 August 24, 2021, the day that Walker filed a Statement of Candidacy, we recommend that the

Commission dismiss the Complaint consistent with the Commission's prosecutorial discretion to
