Find no reason to believe that Biden for President and Keana Spencer in her official capacity as treasurer and Biden Victory Fund and Monica Guardiola in her official capacity as treasurer violated 52 U.S.C. § 30103(c) and 11 C.F.R. § 102.2(a)(2) by failing to amend their Statements of Organization.
    - d. Dismiss pursuant to *Heckler v. Chaney* the allegation that Biden Victory Fund and Monica Guardiola in her official capacity as treasurer violated 52 U.S.C. § 30104(b)(8) and 11 C.F.R. § 104.11(b) by failing to report a debt of greater than \$500 at the time it was incurred.
