On behalf of respondents U.S. Election Assistance Commission, Mona Harrington in her capacity as Executive Director, and Paul Repak in his capacity as Financial Director (hereinafter "Respondents"), I respectfully request an extension of time to respond to the Federal Election Commission's letter informing us that a complaint has been filed in the matter MUR 7946.

Respondents only received actual notice of this complaint on January 11, 2022, when an email was sent to <u>clearinghouse@eac.gov</u> at 2:50 PM from <u>cela@fec.gov</u>. Apparently, previous notices were mailed to an incorrect former address of the Respondents. For your records, please note that the official address for the U.S. Election Assistance Commission is 633 3rd St. NW, STE 200, Washington, DC 20001.

Given actual notice was received on January 11th, pursuant to 52 U.S.C. § 30109(a)(1), a response would be due by January 26th. However, the Respondents need additional time to prepare a response. As a federal agency, there are a number of mandatory reporting requirements currently preoccupying the time and resources of agency staff including the agency's annual report, strategic plan, and responses to executive orders. **Therefore, Respondents respectfully request a fifteen-day extension of time to respond making the deadline February 10, 2022**. This extension will permit the Respondents to gather relevant facts and documents allowing for a complete and thoughtful response.




