COMPLAINT

This complaint is filed under 52 U.S.C. § 30109(a)(1) against Assemblymember Kevin Mullin, Kevin Mullin for Assembly 2022, and Kevin Mullin for Congress (collectively “Respondents”) for violating the Federal Election Campaign Act of 1971, as amended (the “Act”), and the Federal Election Commission (the “FEC” or “Commission”) regulations, as described below. In particular, (1) Respondents appear to have impermissibly spent nonfederal funds on public communications promoting and supporting Mr. Mullin; and (2) Respondents appear to have made prohibited transfers from a nonfederal campaign to Mr. Mullin’s federal campaign committee. We urge the Commission to immediately investigate these violations and

levy appropriate sanctions against Respondents for their failure to comply with these basic requirements of the Act and Commission regulations.

FACTS

Kevin Mullin is a member of the California State Assembly and is a candidate for election to the U.S. House of Representatives from California's newly drawn 15th Congressional District.¹ His principal authorized campaign committee for his congressional campaign is Kevin Mullin for Congress, which registered with the Commission on November 19, 2021.² His candidate controlled committee for his state campaign is Kevin Mullin for Assembly 2022, though he is not currently running for reelection to the Assembly.³

Kevin Mullin for Assembly 2022 recently distributed two mailers that were plainly aimed at supporting Mr. Mullin's election to Congress. The first mailer is a holiday card that was received on or about December 22, 2021 by a resident of California's new 15th Congressional District. A copy of this mailer is attached as Exhibit A. This card contains a heading stating, "Your California State Assemblymember District 22 Kevin Mullin" and states that it was paid for by Kevin Mullin for Assembly 2022. The card includes a photo of Mr. Mullin with his family, and states:

In this season of gratitude, I want you to know how honored I've been to serve you and your family in Sacramento over the past nine years. We have accomplished much for San Mateo County together. I look forward to working with you to keep our county and our state moving forward to a brighter future as we come through this pandemic. Best wishes to you and your family for a

holiday season filled with peace and joy, and for a happy and healthy New Year.

The second mailer is titled “Our Accomplishments Together” and was received by a resident of the new 15th Congressional District on or about December 29, 2021, a copy of which is attached to this Complaint as Exhibit B. The second mailer contains a heading stating, “Your California State Assemblymember District 22 Kevin Mullin.” The mailer also states that it was “Paid for by Kevin Mullin for Assembly 2022.” It contains a list of Mr. Mullin’s purported accomplishments in the Assembly, including stating “Over 60 bills passed into law,” “Expanded voting access and made elections fairer and more equitable,” “Bolstered public safety, protected consumers, and improved transportation,” “Delivered solutions to the housing crisis,” and “Passed landmark legislation to shine a light on dark campaign money.”

LEGAL DISCUSSION

The Act and Commission regulations prohibit federal candidates from soliciting, receiving, directing, transferring or spending funds in connection with a federal campaign unless the funds are in amounts and from sources permitted by the Act.⁴ A federal candidate is also prohibited from transferring funds or assets from the candidate’s nonfederal campaign committee to their federal campaign committee.⁵

Moreover, federal law specifically prohibits individuals holding state elective office and their agents from spending “any funds for a public communication that refers to a clearly identified candidate for Federal office...and that promotes or supports any candidate for that Federal office...unless the funds consist of Federal funds that are subject to the limitations,

prohibitions, and reporting requirements of the Act.”⁶ The term “public communication” includes mass mailings.⁷

Though Mr. Mullin is running for Congress on a platform that touts his purported accomplishments on campaign finance reform, he has violated these very provisions. A month after establishing his federal campaign, Mr. Mullin used the leftover funds in his state campaign account to tout his accomplishments with the very voters that will be voting in his upcoming congressional election. This constitutes a prohibited transfer of state committee funds to his federal committee.⁸

Moreover, Kevin Mullin for Assembly 2022 appears to have used federally impermissible funds to pay for public communications that promote and support his federal candidacy. The two mailers unquestionably promote and support Mr. Mullin. The first states, “We have accomplished much for San Mateo County together. I look forward to working with you to keep our county and our state moving forward to a brighter future as we come through this pandemic.” The second discusses his purported legislative accomplishments in the Assembly.

Additionally, it appears as if the state committee paid for these mailers with federally impermissible funds. As of this time, the most recent nonfederal campaign finance report available to the public demonstrates that almost all of the state committee’s receipts are not federally permissible.⁹ On the semiannual report covering the first half of 2021, the state

committee disclosed a mix of corporate donations (BNSF Railway Company, Walt Disney Co., Novartis, Ultragenyx Pharmaceuticals) and donations from nonfederal separate segregated funds. The direct corporate contributions are plainly prohibited by federal law.¹⁰ The SSF contributions are also likely impermissible. To donate federally, an SSF is required to register within 10 days of formation.¹¹ These nonfederal SSFs have not so registered, are not subject to FEC regulations prohibiting corporate facilitation, and, in any case, there is no indication whether the donations were made with federally permissible funds. In fact, the state committee only discloses a single contribution from an individual on its report. Thus, it does not appear as if the state committee had sufficient federally permissible funds on hand to pay for these mailings. Accordingly, Respondents appear to have violated the Act's soft money prohibition.

REQUESTED ACTION

As we have shown, Respondents have likely violated the Act by expending nonfederal funds to support Mr. Mullin's federal candidacy, and making public communications in support of Mr. Mullin's federal candidacy using nonfederal funds. Given that Mr. Mullin is a self-professed campaign finance reformer, these violations may have been knowing and willful. We respectfully request that the Commission immediately investigate these violations and that Respondents be enjoined from further violations and fined the maximum amount permitted by law.

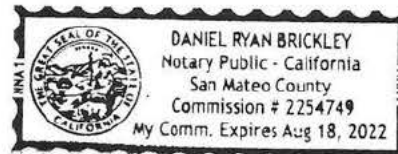
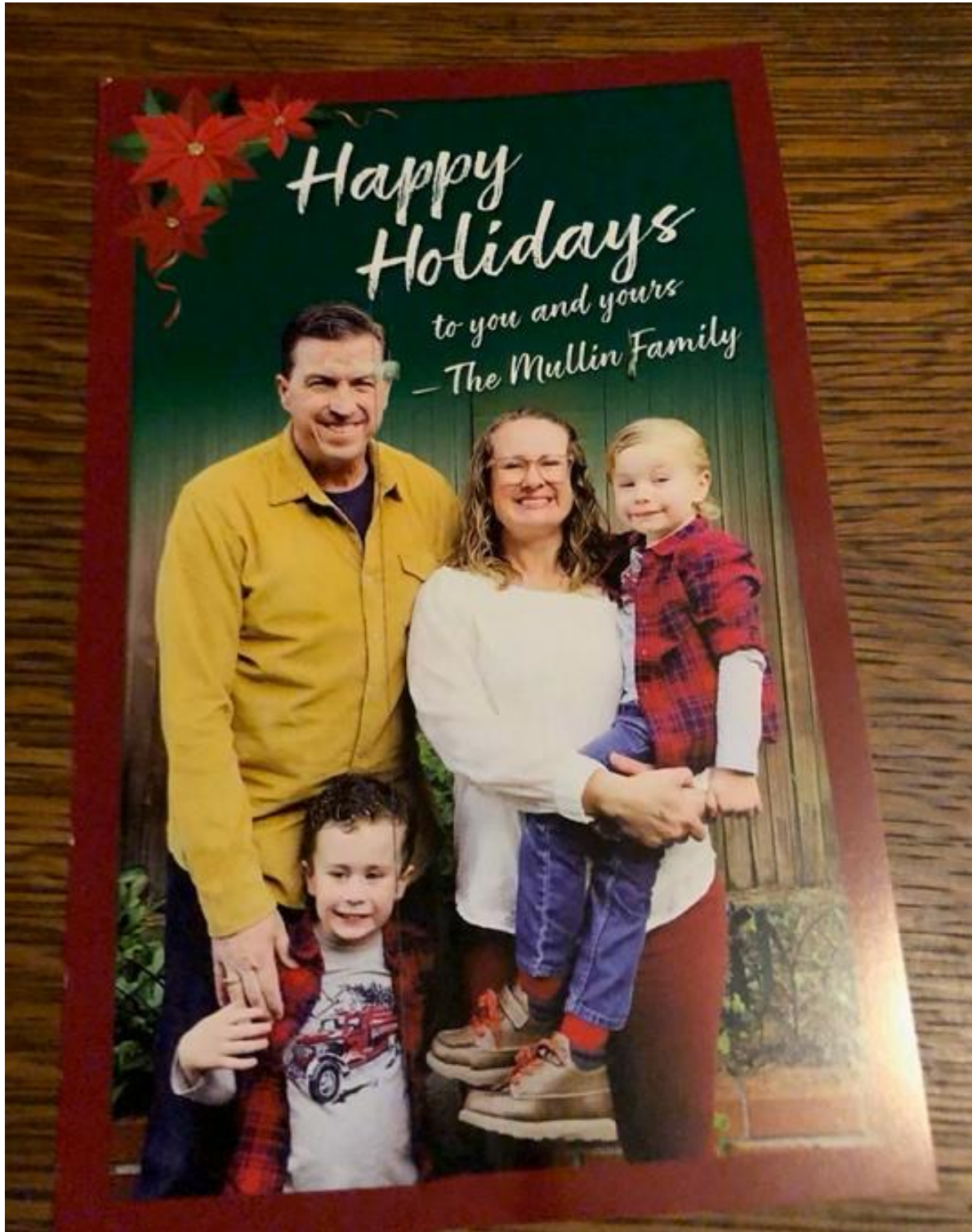

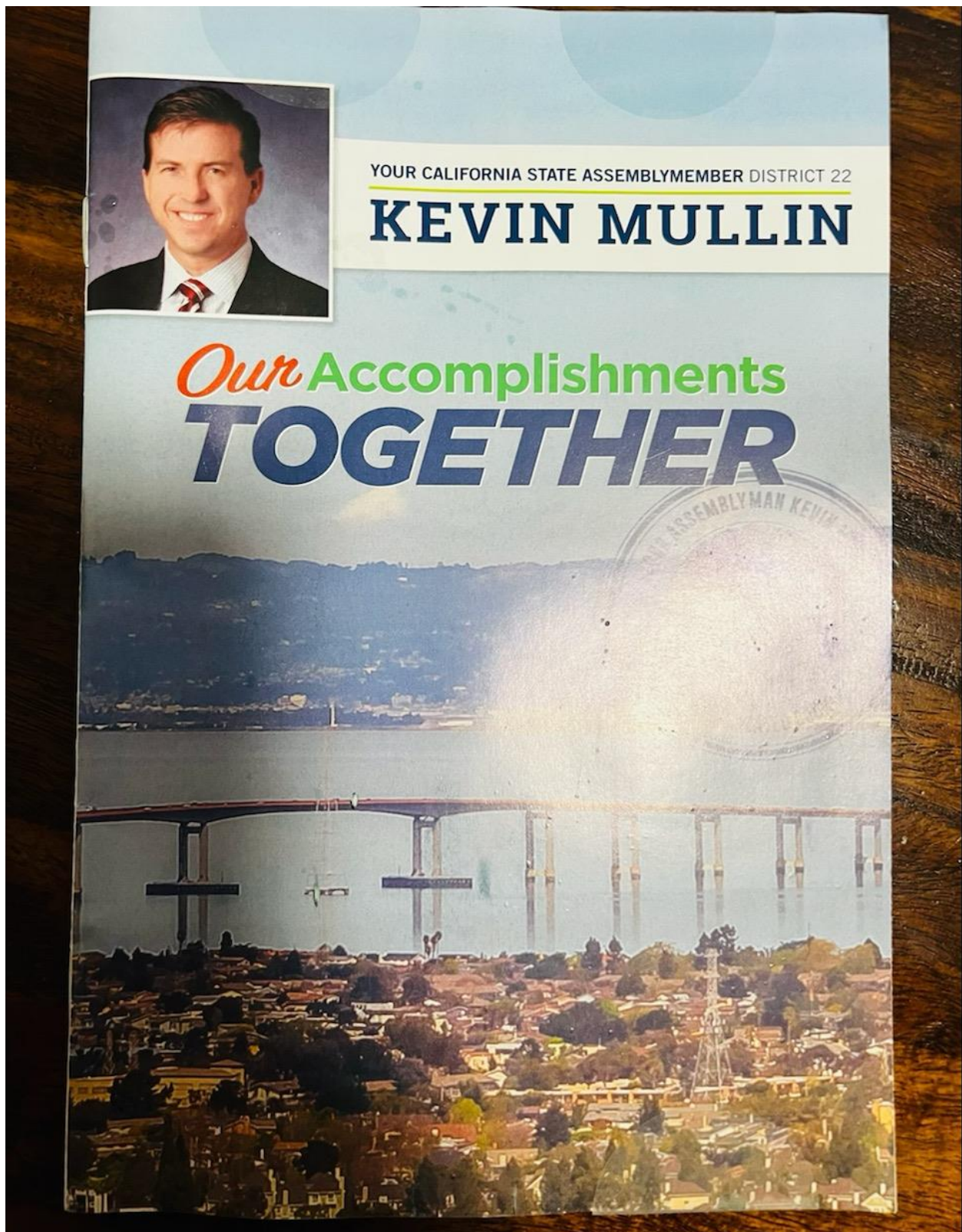
