Dear Mr. Luckett,

I have received your letter of February 15, 2022 concerning my complaint against ActBlue, 366 Summer Street, Somerville, MA 02144-3132 and UBS Financial Services, Inc. P.O. BOX 766, Union City, NJ 07087, now listed by you as MUR7959. I have only minor amendments to my complaint. I have received a 74 page list of my credit card charges from UBS, without any covering letter so I only know it's from UBS by the address on the return label. It is oddly divided into three sections, not marked, with each starting with last years' date. As far as I could see, none of the charges I am contesting are included. I have received a few letters from organizations that expected my donation, but were stymied by my having changed my credit card number, and they must have used my old number. I do not charge anything to my old number, therefore either they were very late in trying to obtain the funds, or more likely, ActBlue is continuing their fraudulent charges. I have found 13 emails I have printed out from June 22, 2018 to November 11, 2018 (Nov. one enclosed) that protested to ActBlue that whenever I donated, it was automatically set as recurrent. They no longer do that, but their fraudulent attitude prevailed early.

There are no new credit card charges on my UBS new Visa Account that states ActBlue, since I stopped ever donating through them. However, I find two suspicious doubling of contributions to "Emily's List" as to same amount, same date, same time and listed sequentially on the Statement. I do NOT ever double donations. So maybe the ultra-partisan person doing this is at UBS Credit Cards Division (enclosed as a photo)
