RE: Impermissible coordination between federal candidate committee Casten for Congress (C00648493) and Super PAC SunshinePAC (C00641530)

02/09/2022

To whom it may concern,

There exists reason to believe that Casten for Congress (C00648493) violated federal election law by impermissibly coordinating with SunshinePAC (C00641530), an independent expenditure only committee, on paid communications targeting Kelly Mazeski, a candidate for Congress, resulting in a contribution exceeding federal limits.

FEC regulations describe coordination as any electioneering expenditure "made in cooperation, consultation or concert with, or at the request or suggestion of, a candidate, a candidate's authorized committee, or a political party committee." (11 CFR 109.21) Federal Election Commission regulations provide for a three-pronged test to determine whether a communication is coordinated with a candidate: the communication is financed, whole or in part, by a person other than that candidate, the communication satisfies one of the content standards in § 109.21(c), and the communication satisfies one of the conduct standards in § 109.21(d). In the case of independent expenditures made by SunshinePAC opposing Kelly Mazeski in the 2018 Democratic Primary in Illinois 6th Congressional District, facts show that these three standards of coordination were met between Casten for Congress and SunshinePAC making these electioneering communications an in-kind contribution to Casten for Congress exceeding federal contribution limits.

SunshinePAC was formed on May 25th, 2017 in filings with the Federal Election Committee as an independent expenditure-only committee, otherwise known as a Super PAC. On March 12th, 2018 Tom Casten of 8 E Third Street, Hinsdale, IL 60521 made a \$100,000 contribution to SunshinePAC. On March 15th, 2018 Tom Casten made an additional \$50,000 contribution to SunshinePAC. These contributions, totaling \$150,000, were the only contributions received by SunshinePAC in the first quarter of 2018.

On March 13th, 2018 SunshinePAC filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$57,699 in "printing" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election.

On March 14th, 2018 SunshinePAC filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$30,000 in "advertising" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election.

On March 20th, 2018 SunshinePAC filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$42,000 in "phones and advertising" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election. These communications were "paid for, in whole or in part, by a person other than that candidate, authorized committee, or political party committee"(11 CFR 109.21) establishing the first prong of the Commission's definition of communication.

In March of 2018, Kelly Mazeski was a candidate in the Illinois 6th District Democratic primary. At this time Sean Casten was also a candidate in the Illinois 6th District Democratic Primary. The federal committee Casten for Congress (C00648493) is Sean Casten's principal campaign committee. Sean Casten is the son of Tom Casten. In sum, SunshinePAC expenditures opposing Sean Casten's opponent Kelly Mazeski totaled \$129,699. SunshinePAC filed requisite reports with the Commission for each of these expenditures as independent expenditures opposing Kelly Mazeski in Illinois 6th Congressional District satisfying the Commission's content standard as an electioneering communication(11 CFR 100.29) under § 109.21(c)(1).

In March of 2018, Michael Garton was Sean Casten's campaign manager, an agent of Casten for Congress, on the Casten for Congress payroll since January of 2018. At that time Michael Garton was living with Tom Casten, the father of Sean Casten and sole financier of SunshinePAC in the first quarter of 2018, at 8 E Third Street, Hinsdale, IL 60521. Mr. Garton's residency at the home of Tom Casten during the first quarter of 2018 is established through Mr. Garton's State of Illinois voter registration, state ID WJ925Q2Y, and through a series of FEC filings listing his address of residency as 8 E Third Street, Hinsdale, IL 60521.

Mr. Garton was living with Tom Casten while serving as the principal agent of Casten for Congress during the period that Tom Casten contributed substantial sums to super PAC SunshinePAC, which then executed a large independent expenditure opposing an opponent of Sean Casten and Casten for Congress in the Illinois 6th District Democratic Primary. The intimate relationship between Mr. Garton and Tom Casten and the clear lack of a firewall raise great concern that SunshinePAC expenditures were "created,

produced, or distributed after one or more substantial discussions about the communication between the person paying for the communication, or the employees or agents of the person paying for the communication, and the candidate who is clearly identified in the communication, or the candidate's authorized committee, the candidate's opponent, the opponent's authorized committee, or a political party committee."(11 CFR 109.21) The relationship between Mr. Garton and Tom Casten as cohabitants strongly imply satisfaction of the Commission's conduct standard in § 109.21(d)(3).

I believe these facts show a reason to believe that an agent of Casten for Congress coordinated with a federal Super PAC operating as an independent expenditure committee, opposing an opponent of Sean Casten in the Illinois' 6th District Democratic primary election, resulting in a contribution exceeding federal limits.



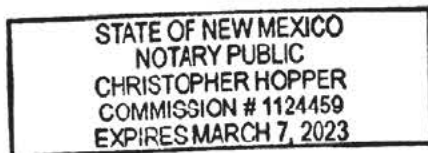

Dear Ms. Barber:

This is in response to your email to the Federal Election Commission (the “Commission”), received on January 20, 2022. The Commission is an independent regulatory agency charged with administering and enforcing the Federal Election Campaign Act of 1971, as amended (the “Act”), and Chapters 95 and 96 of Title 26, United States Code.

The Act and Commission regulations require that a complaint meet certain requirements. Your email does not meet these requirements. Specifically, your submission does not clearly describe facts showing specific violations that fall under the Commission's jurisdiction. In addition, your submission was not sworn to and notarized, as required under the Act. Consequently, the Commission can take no action at this time unless the allegations are refiled meeting the requirements for a properly filed complaint.

If you desire the Commission to look into the matters discussed in your email, please clearly describe the facts regarding each allegation and how they violate the Act. We have provided below a listing and description of the required prerequisites to file a legally sufficient complaint, along with some suggested items that should be included in your resubmission in order to assist the Commission in processing the matter.

- (1) A formal complaint should contain a clear and concise recitation of the facts describing the violation of a statute or law over which the Commission has jurisdiction. (11 C.F.R. § 111.4).
- (2) Its contents must be sworn to and signed in the presence of a notary public and shall be notarized. (52 U.S.C. § 30109(a)(1); 11 C.F.R. § 111.4(b)(2)). The notary must indicate as part of the jurat that such swearing occurred. The preferred form is "Subscribed and sworn to before me on this ____ day of ____, 2021."
- (3) A formal complaint should be accompanied by supporting documentation if known and available to the person making the complaint. (11 C.F.R. § 111.4).
- (4) A complaint must be in writing. (52 U.S.C. § 30109(a)(1)).
- (5) A formal complaint must contain the full name and address of the person making the complaint. (11 C.F.R. § 111.4).
- (6) A formal complaint should clearly identify as a respondent each person or entity who is alleged to have committed a violation. (11 C.F.R. § 111.4).
- (7) A formal complaint should identify the source of information upon which the complaint is based. (11 C.F.R. § 111.4).

Please note that this matter will remain confidential for a 15 day period to allow you to correct the defects in your complaint. If the complaint is corrected and refiled within the 15 day period, the respondents will be so informed and provided a copy of the corrected complaint. The respondents will then have an additional 15 days to respond to the complaint on the merits. If the complaint is not corrected, the file will be closed and no additional notification will be provided to the respondents.

I wish to call your attention to compelling evidence of an issue within your jurisdiction concerning agents within the Casten for Congress committee and that may have violated The Bipartisan Campaign Reform Act of 2002 and corresponding federal election regulations 11 CFR Part 109.2 U.S.C. 431(17), CFR 109.21(c)(1).3, 11 CFR 109.21(c)(4)(i)-(iv) through impermissible coordinating communication with agents of My Committee (SunshinePAC), an independent expenditure only committee.

The publicly available evidence that suggests further review is necessary is as follows:

- Tom Casten, a private citizen, is the father of then candidate Sean Casten, and a principal contributor to the PAC in question
- Tom Casten's residency was 8 E 3rd St, Hinsdale, IL 60521 in March of 2018
- Michael Garton was Sean Casten's campaign manager and an officer of Casten for Congress in January 2018 through March 2018
- Michael Garton reported his residency also at 8 E 3rd St, Hinsdale, IL 60521 in March of 2018, registered to vote using the same address and did so during the 2018 primary
- Multiple contributions made by Tom Casten to the registered PAC were used in direct opposition to another candidate in the same primary race

In March of 2018, Kelly Mazeski was a candidate in the Democratic primary in Illinois 6th District, running against then candidate Sean Casten, who's principal campaign committee is Casten for Congress (ID C00648493). In March of 2018, Michael Garton

was Sean Casten's campaign manager, an officer of Casten for Congress, and had been paid as an agent of Casten for Congress since January of 2018 while living with Tom Casten, the father of Sean Casten, at 8 E Third Street, Hinsdale, IL 6052, a single-family residential building. Michael Garton registered to vote at this Hinsdale address and did so in the March 20th Democratic primary.

Multiple contributions made by Tom Casten to the registered PAC align with communication and actions that directly aided the candidate's campaign, through communication clearly prohibited by FEC rules, then managed by Michael Garton, outside of what a reasonable review would consider coincidental:

- May 25, 2017: My Committee (SunshinePAC) was formed in filings with the Federal Election Committee as a Super PAC.
- March 12th, 2018: Tom Casten of 8 E Third Street, Hinsdale, IL 60521 made a \$100,000 contribution to My Committee (SunshinePAC)
- March 13th, 2018: My Committee (SunshinePAC) filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$57,699 in "printing" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election.
- March 14th, 2018: My Committee (SunshinePAC) filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$30,000 in "advertising" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election.
- March 15, 2018: Tom Casten made an additional \$50,000 contribution to My Committee (SunshinePAC)
- March 20th, 2018: My Committee (SunshinePAC) filed a 24/48 Hour Report of Independent Expenditure with the FEC for \$42,000 in "phones and advertising" expenses opposing Kelly Mazeski in the Illinois 6th Congressional District Democratic primary election.

In what appears to be a continued pattern of behavior, the Casten for Congress (ID C00648493) committee has elected to retain the same treasurer of the candidate's Leadership PAC, "Science Truth and Expertise Matter PAC" (ID: C00747642) despite

prior complaints of this nature in reporting expenses and independent communications; *Democratic Senatorial Campaign Committee v. FEC*, 745 F. Supp. 742 (D.D.C. 1990).

For your review are several publicly available documents which are already on file with the FEC:

- The state voter file ID attached to his then registration is WJ925Q2Y.
- FEC filings indicating Michael Garton's employment with Casten for Congress in March of 2018
- FEC filings indicating My Committee (SunshinePAC) formation as a SuperPac in 2017
- FEC filings detailing Tom Casten's home address and contributions to My Committee (SunshinePAC) in March of 2018
- Proof of Michael Garton's residency at 8 E 3rd St, Hinsdale, IL 60521 in March of 2018
- FEC filings detailing My Committee (SunshinePAC) expenditures opposing Kelly Mazeski in the 2018 Democratic primary in Illinois 6th District

These facts show a reason to believe that an officer of Casten for Congress may have coordinated with a federal Super PAC operating as an independent expenditure committee, opposing an opponent of Sean Casten in the Illinois' 6th District Democratic primary election and warrant a thorough investigation in the interest of election integrity and adherence to campaign finance regulation.
