**Re: Campaign Finance Violations by Defending Main Street Super PAC, Inc.**

Dear Ms. Stevenson:

Pursuant to 52 U.S.C. § 30109(a), I write to file a complaint against Defending Main Street Super PAC, Inc and Sarah Chamberlain, in her official capacity as Treasurer (collectively, the “PAC”), for violation of the Federal Election Campaign Act (“the Act” or “FECA”), 52 U.S.C. § 30104, and the regulations of the Federal Election Commission (“the Commission” or “FEC”).

The PAC has violated Federal Law by repeatedly mis-reporting its independent expenditures on both its 48-hour reports and its regular monthly reports to the FEC. Specifically, the PAC appears to have deliberately disguised the target of its independent expenditures in order to frustrate online search capabilities and public disclosure of its activities.

**Facts of the Violations**

The PAC is a federal independent expenditure-only political committee that first registered with the FEC on December 26, 2012.

In 2022, the PAC has engaged in a series of defamatory mailings concerning Congressman Alex Mooney. While the defamatory content of these mailings is not a matter under the FEC’s jurisdiction but rather a matter for the courts, the inaccurate and misleading reporting of these expenditures is firmly under the jurisdiction of the FEC.

In four (4) separate reports to the FEC, the PAC has disguised the target of its misleading expenditures. On the 48-Hour Reports that the Committee filed on January 19, 2022; January 27, 2022; February 4, 2022; and the Committee’s February Monthly Report filed on February 10, 2022; the PAC referred to the target of their attack ads as “Alex Moody” [sic]. In a February 3, 2022 letter to the PAC, Mooney for Congress 2022 flagged this issue, yet the PAC continues to file the same misleading reports to the Commission. *See Attachment 5* at page 2.

### Analysis

The Act requires committee treasurers to file accurate reports of the committee's receipts and disbursements. 52 U.S.C. § 30104; 11 CFR 104.1(a). This requirement includes the accurate reporting of independent expenditures. 52 U.S.C. § 30104(b)(4)(H)(iii); 11 C.F.R. § 104.3(b)(I)(vii).

Every political committee that makes independent expenditures must report them in their regularly scheduled disclosure reports. 11 CFR § 104.4(a). In addition, a political committee, like the PAC, that makes or contracts to make independent expenditures aggregating \$10,000 or more for an election in any calendar year, up to 12 and including the 20th day before an election, must report these expenditures within 48 hours. 52 U.S.C. § 30104(g)(2); 11 C.F.R. § 104.4(b)(2). "For each independent expenditure reported, the committee must also provide a statement which indicates whether such independent expenditure is in support of, or in opposition to a particular candidate, as well as **the name of the candidate and office sought by such candidate** (including State and Congressional district, when applicable)." 11 CFR § 104.3(b)(3)(vii)(B) (emphasis added).

Here, the PAC has repeatedly violated these rules by failing to accurately "provide a statement which indicates whether such independent expenditure is in support of, or in opposition to a particular candidate, as well as the name of the candidate and office sought by such candidate (including State and Congressional district, when applicable)." 11 CFR § 104.3(b)(3)(vii)(B) (emphasis added).

While the PAC may argue that its errant reports are merely the result of typographical errors, the facts do not support such a contention. First, the PAC did not file an inaccurate report on only one occasion. It has done so repeatedly; on four (4) separate occasions, even after the PAC was made aware of this issue. Moreover, despite having been made aware of the issue, the PAC has not amended its inaccurate reports to the Commission, as required by law.

This would suggest that the PAC's reporting was by design: that the PAC intentionally mis-reported its independent expenditures in order to frustrate the ability of the public to accurately review and understand the Committee's independent expenditures. Likely understanding that attacking an incumbent Republican Congressman was wholly inconsistent with its stated mission of "defend[ing] key incumbent Republican seats. . .", the Committee appears to have intentionally misstated its activities in violation of the Act. *See* Defending Main Street Super PAC, *available at* [www.defendingmainstreet.com](http://www.defendingmainstreet.com) (last accessed Feb. 25, 2022).

The Commission has previously fined committees for failure to accurately report their independent expenditures. *See, e.g.*, MUR # 7896 (Integrity NJ); MUR # 7545 (Tea Party


Majority Fund); MUR #7476 (Ohio First PAC). Given the repeated nature of the violations here, a similar penalty would be appropriate under the present circumstances.

**Conclusion**

Upon information and belief, and based upon the facts set forth hereinabove, the Respondents, Defending Main Street Super PAC, Inc., and Sarah Chamberlain, in her official capacity as treasurer thereof, have violated the Federal Election Campaign Act of 1971, as amended.



Dear Ms. Chamberlain:

As counsel for Congressman Alex Mooney and his campaign committee, Mooney for Congress 2022, we write to demand that Defending Main Street Super PAC, Inc. (“you”) immediately cease and desist from engaging in the tort of false light invasion of privacy against, and making defamatory statements about, my clients as you are presently doing in your print media campaign. We are prepared to exercise all legal remedies to stop the distribution of these false and defamatory advertisements.

At their most egregious, you have doctored a photo of Congressman Mooney to create the false light impression that Congressman Mooney has been arrested or charged with a crime; something that is categorically false. Your fabricated image is both defamatory *per se* and constitutes clearcut false light invasion of privacy.<sup>1</sup>

The United States Supreme Court has held that the distribution of a “mugshot” “imput[es] criminal behavior . . . [and] is generally considered defamatory *per se*, and actionable without proof of special damages.” *Paul v. Davis*, 424 U.S. 693, 697 (1976); *see also Colcord v.*

*Gazette Pub. Co.*, 145 S.E. 751, 753 (W. Va. 1928) (“Any printed or written publication imputing to another a crime . . . is actionable *per se*, without proof of special damages.”).

The depiction of Congressman Mooney also constitutes the tort of false light invasion of privacy. By depicting Congressman Mooney in a false light before the public, your advertisement is an actionable invasion of privacy under West Virginia law. Syl. Pt. 12, *Crump v. Beckley Newspapers, Inc.*, 320 S.E.2d 70, 74 (W.Va. 1983).<sup>2</sup>

Through your advertisement, you have committed false light invasion of privacy against Congressman Mooney, since your advertisement: 1) gave publicity to a matter concerning Congressman Mooney that places the Congressman before the public in a false light, (2) the publicity was widespread as a mass mailing, (3) the matter of the publicity was false, (4) the false light in which Congressman Mooney was placed would be highly offensive to a reasonable person, and (5) you had knowledge of or acted in reckless disregard as to the falsity of the publicized matter and the false light in which Congressman Mooney would be placed (i.e., actual malice). See *Taylor v. West Virginia Dep’t of Health & Human Res.*, 788 S.E.2d 295, 315-316 (W. Va. 2016) (citing Restatement (Second) of Torts § 652E (1977); *Crump*, 320 S.E.2d at 87-88.

Here, all of those criteria are readily met by your recklessly false depiction of Congressman Mooney. First, by inventing a mugshot of Congressman Mooney, the Congressman was depicted in a false light wholly inconsistent with his stellar record of public service. Second, the publication was widespread, as demonstrated by your 48-hour report to the Federal Election Commission dated January 27, 2022, noting that your committee spent \$50,067.54 for a mailing opposing “Alex Moody” [sic]. Third, the depiction was plainly false given that it was fabricated by your committee. Fourth, the depiction of Congressman Mooney as a criminal is highly offensive and defamatory *per se*. Finally, you had knowledge that this depiction was false since you created it.

Accordingly, we demand that you immediately cease and desist from this unlawful depiction of Congressman Mooney.

In addition, your advertisements make a number of defamatory statements about Congressman Mooney that only serve to underscore your reckless disregard for the truth in this matter.

As an example, your advertisements repeatedly allege that Congressman Mooney is “under federal investigation”, which wrongly implies some sort of law enforcement investigation. As your cited materials show, Congressman Mooney is simply the subject of a

partisan committee inquiry of the Democrat-controlled U.S. House of Representatives. Once again, this imputation of criminal conduct constitutes defamation and false light invasion of privacy.

Your advertisements also make demonstrably false statements about Congressman Mooney's residency and ties to the State of West Virginia. As you are well aware, Congressman Mooney is in his **fourth** term representing West Virginia's Second Congressional District, where he resides and is raising his children.

Your advertisements also falsely state that Congressman Mooney left "the Maryland State Senate to run for office in three different states. . ." This statement demonstrably misstates Congressman Mooney's biography and timeline by conflating a college-age run by Congressman Mooney that occurred decades ago with current day events.

These patently false statements when combined with your fabricated "mugshot" of Congressman Mooney constitute clearcut defamation and false light invasion of privacy under West Virginia law and represent a substantial and immediate harm to the campaign and to Congressman Mooney. Accordingly, my clients demand that you **immediately** cease and desist from distributing the advertisements in question, and from making any other defamatory statements about, or depictions of, Congressman Mooney.

Furthermore, pursuant to Rule 34 of the Federal Rules of Civil Procedure, we hereby notify you, along with your principals, employees, and agents (including but not limited to all advertising vendors, contractors, and those engaged in raising money, with and without compensation, for your organization), to preserve all electronically stored information, copies and backup, along with any paper files which you, or your principals, employees, or agents, maintain relevant to this dispute.

My clients expressly reserve the right to seek in discovery electronic data in your custody and control that is relevant to this action, including without limitation emails and other information contained on your computer systems and any electronic storage systems. My clients consider this electronic data and paper files to be valuable and irreplaceable sources of discoverable information in this matter. Accordingly, my clients, hereby place you, along with your principals, employees, and agents (including but not limited to all advertising vendors, contractors, and those engaged in raising money, with and without compensation, for your organization), on notice to preserve all documents regarding Congressman Mooney and to not allow the deletion of any electronic communications, such as emails, relating to Congressman Mooney.


