**RE: Response of Save America Joint Fundraising Committee and Bradley  
Crate in his capacity as Treasurer in MUR 7968**

Dear Mr. Luckett:

This Response is submitted by the undersigned counsel on behalf of Save America Joint Fundraising Committee and Bradley Crate in his capacity as Treasurer (the "Respondent") in response to the March 17, 2022 complaint from American Bridge 21<sup>st</sup> Century, or AB PAC, designated as Matter Under Review 7968 (the "Complaint"). The Complaint was originally filed on March 17, 2022 and Respondent is a joint fundraising committee comprised of Save America (C00762591) and Make America Great Again PAC (C00580100) (collectively, the "Participating Committees").

For the reasons set forth in the response to this MUR 7968 by Donald J. Trump, Save America, and Bradley Crate in his capacity as Treasurer, dated April 6, 2022, the Commission should find no reason to believe Respondents violated the Federal Election Campaign Act of 1971, as amended (the "Act") or any Commission regulations ("Regulations"). Accordingly, the Commission should find no reason to investigate and the Complaint should be dismissed as to all Respondents.


