
**RE: Response of Save America, and Bradley Crate in his capacity as

This Response is submitted by the undersigned counsel on behalf of Save America and Bradley Crate, in his capacity as Treasurer (collectively, the "Respondents") in response to the March 23, 2022, Complaint from Castro for America and John Anthony Castro ("Castro" or the "Complainants), designated as Matter Under Review 7969 (the "Complaint").

For the reasons set forth in the response to this MUR 7969 by Donald J. Trump, Save America, and Bradley Crate in his capacity as Treasurer, dated April 7, 2022, the Federal Election Commission (the "Commission") should find no reason to believe Respondents violated the Federal Election Campaign Act of 1971, as amended (the "Act") or any Commission regulations ("Regulations"). Accordingly, the Commission should find no reason to investigate and the Complaint should be dismissed as to all Respondents.


