To Whom it May Concern:

This letter is written in response to that certain Complaint dated April 21, 2022 filed with the Federal Election Commission by Charles Dudek of Oahurst, California.

I am the President of Buckingham Property Management (“BPM”). On or about February 22, 2022, BPM made a political contribution to the Committee of Magsig for Congress in support of Nathan Magsig’s candidacy for California’s 5th Congressional District. In doing so, BPM was unaware of the prohibition of corporations to make political contributions to Federal office candidates under the Federal Election Campaign Act of 1971. BPM has lawfully supported candidate Magsig in his bid for State and local offices. BPM was unaware of the difference in Federal laws prohibiting corporations from making contributions to Federal candidates. It was an oversight by BPM in making said contribution. Since receiving the Complaint, BPM has been contacted by the Committee of Magsig for Congress who refunded the contribution. Enclosed is a copy of their letter and check. BPM wishes to put this matter behind it, and therefore asks that this matter be closed without further action. In the event you have additional questions, please contact our attorney Paul C. Franco. The facts set forth in this response are made of my own personal knowledge, and are made under penalty of perjury under the laws of the State of California.



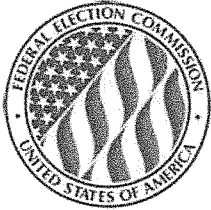


