RE: Rizzo for Congress – Use of robocalls without required paid for disclaimer

Dear General Counsel:

This office writes to file this complaint regarding violations of the Federal Campaign Act of 1971, as amended (the "Act") by Phil Rizzo for Congress ("Rizzo campaign"), the principal campaign account of Phil Rizzo, a candidate for Congress in the June primary for the 7<sup>th</sup> congressional district in New Jersey ("NJ-CD7"). David Satterfield is the listed treasurer of Phil Rizzo for Congress with the address of 228 S. Washington Street, Alexandria, Virginia 22314. As outlined below, this complaint provides facts which clearly establish that the Rizzo campaign has violated the Act and the regulations of the Federal Election Commission ("FEC") by expending campaign funds without the proper paid for disclaimer with the express intention of creating confusion for voters of NJ-CD7 in the upcoming June primary.

McCarter & English, LLP represents Tom Kean, Jr., a Republican candidate for Congress in NJ-CD7 running in the June primary.

The proofs provided here include the following:

- An actual recording of the robocall;
- The telephone number captured by voters from their home caller identification device (973.264.0052);
- A screenshot of the automated response from the Rizzo campaign for anyone attempting to call the telephone number from their caller ID device; and,
- Actual complaints from voters in NJ-CD7 who received the robocall from the Rizzo campaign.

Specifically, between the hours of approximately 11:00 p.m. on April 19, 2022 and 12:30 a.m. on April 20, 2022, the Rizzo for Congress campaign initiated so-called robocalls via an automatic telephone dialing systems ("ATDS") to likely Republican voters in the New Jersey primary. The robocall (copy of the recording attached here) is a negative attack ad against Tom Kean, Jr. Upon information and belief, the voice of the person recording the robocall is candidate Phil Rizzo. The recording mentions Tom Kean by name four times, references a website titled the RealTomKean.com, and then concludes without any identification of the caller, and, most importantly, without providing the required FEC disclaimer which must identify who paid for the call, state whether the call is authorized by any candidate or candidate's committee, and provide the committee's street address, website address or phone number. Besides the negative message of the call, the obvious intention of the late-night call is to annoy and confuse potential primary voters or to dissuade them from even participating in the June election.

As the Act, FEC regulations and the FEC's own Campaign Guide states, "Disclaimers must be presented in a clear and conspicuous manner to give the reader, observer, or *listener* adequate notice of the identity of the person or political committee that paid for the communication." 110.11 (c)(1) (Page 74) (Emphasis added.) This includes "public communications" such as emails, phone banks and robocalls to more than 500 recipients. The clear intent of the Act and the FEC's regulations is to prohibit this exact situation where the source of the person or entity producing and paying for the communication is hidden from voters.

Therefore, based on the foregoing information, there is clear evidence establishing a violation of the Act and to support an investigation and fine by the FEC against Phil Rizzo for Congress.

Both calls were received between 12:15 and 12:40 a.m. - You woke me up from a sound sleep and, since the only calls that come in the middle of the night are typically from a family member in distress, these calls were upsetting and generated anxiety. The caller ID indicated they were generated from a Madison number. I would ask that you please take a closer look at your campaign operations to ensure that this does not happen again. At 11:17 pm on Tuesday, April 19th your automated message called my home at My husband wakes at 4 am to get up for his job. He was asleep and awaken. My children were awaken as was I. Since this was a number that looked local, I assumed it was a town emergency. Imagine my surprise when it was a prerecorded message from Tom Kean, Jr talking about critical race theory. I understand it is campaign season but if you are trying to reach families who have eligible voters and would like them to hear your message, I suggest you set the parameters for these automated calls to be no later than 7pm. Unsolicited calls are typically unappreciated regardless but I understand why so many use this as an option to gain attention. This was not well received in my home at such a late hour.
