Re: SECOND SUPPLEMENT RE: MUR 7990/NEW ASSERTED VIOLATION

Dear FEC Office of General Counsel:

By email dated May 3, 2022, Acting Assistant General Counsel Roy Q. Luckett acknowledged the FEC's receipt, on April 26, 2022, of my complaint regarding the registered campaign committee "Kim Klacik for Congress" (C00726117). Thereafter, a supplement to my initial complaint was submitted on August 24, 2022, which the FEC acknowledged received on August 30, 2022. A copy of that most recent acknowledgement is attached to this correspondence for your convenience as **Attachment #1**.

Since the filing of my initial complaint and my first supplement regarding it, Ms. Klacik's campaign committee has filed a campaign finance report for the third quarter of 2022. I have had an opportunity to review Ms. Klacik's most recent report, which appears to indicate an altogether new violation of federal campaign finance law: Accepting and reporting—as a "loan" from a non-financial institution—a contribution that significantly exceeds applicable contribution limits.

In particular, Ms. Klacik’s most recent campaign finance report—attached to this correspondence as **Attachment #2**—indicates that Ms. Klacik accepted a “loan” from Dickinson Wright PLLC in the amount of \$23,122.10 during the most recent reporting period alone. *See id.* at 15. That reported “loan” is highlighted in the attachment for your Office’s convenience and review.

Ms. Klacik’s most recent report also reflects a total loan from Dickinson Wright PLLC in the amount of \$55,802.10. *See id.* This total loan amount includes an additional \$32,680.00 reported loan from Dickinson Wright PLLC that was made during the second quarter of 2022. That “loan” is reflected on Ms. Klacik’s preceding report filed on July 15, 2022 and is similarly highlighted for your Office’s convenience and review. *See Attachment #3* at 15.

As the FEC is well aware—and as it conspicuously advises the public—loans to a candidate’s campaign committee that are not personal loans and are not loans from financial institutions are “considered a contribution from the donor to the campaign, subject to the per-election limit and reportable by the campaign.” *See* FED. ELECTION COMM’N, *Personal loans from the candidate*, <https://www.fec.gov/help-candidates-and-committees/handling-loans-debts-and-advances/personal-loans-candidate/> (last accessed Oct. 30, 2022 at 2:53 p.m. CST). *See also* 11 C.F.R. § 100.52(a) (“**A . . . loan** (except for a loan made in accordance with 11 CFR 100.82 and 100.83), advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office **is a contribution.**”) (emphases added). As previously detailed, the relationship between Ms. Klacik’s campaign and Dickinson Wright PLLC—one that previously resulted in substantial reported expenditures from Ms. Klacik’s campaign to Dickinson Wright PLLC, which are now being reported as loans from Dickinson Wright, PLLC to Ms. Klacik’s campaign—also arises from pending *personal* litigation initiated by Ms. Klacik individually, irrespective of her campaign. Thus, because Ms. Klacik and her committee are not “the regular employer of the individual rendering the services,” and additionally because such services were not provided “solely to ensure compliance with the Act or 26 U.S.C. 9001 et seq. and 9031 et seq.,” the reported loan at issue cannot reasonably be characterized as falling within the “[l]egal or accounting services to other political committees” exemption in 11 C.F.R. § 100.86, either.

Put another way: Ms. Klacik is reporting a \$55,802.10 total loan from Dickinson Wright PLLC to her campaign, *see Attach. 2* at 15, which includes \$23,122.10 loaned during the third quarter of 2022 and \$32,680.00 loaned during the second quarter of 2022. *See id.*; *see also Attach. 3* at 15. Under applicable law, these “loans” are—and they are treated as—contributions that are subject to the FEC’s 2021–22 contribution limits. Because a \$55,802.10 loan from Dickinson Wright PLLC to Ms. Klacik’s campaign committee dramatically exceeds the maximum applicable \$2,900.00 contribution limit for 2021–22, though, I respectfully request that the FEC investigate Ms. Klacik’s apparent continued violation of federal campaign finance law, and that the FEC additionally take whatever enforcement action it deems appropriate against all additional individuals and entities who are determined to have participated in the violation. As previously, my concern that Ms. Klacik may be violating federal campaign finance law is also compounded further by her committee’s many previous violations of federal campaign

finance law, which resulted in the FEC assessing a substantial monetary fine. See Administrative Fine #4220 against KIM KLACIK FOR CONGRESS, ID: C00726117, FED. ELECTION COMM'N, <https://www.fec.gov/data/legal/administrative-fine/4220/> (last visited Oct. 30, 2022).

Pursuant to this Office's policy and applicable law, this second supplement/new complaint has been signed, sworn, and notarized as set forth below, and my full name and address are set forth above.

**DESCRIPTION OF PRELIMINARY PROCEDURES
FOR PROCESSING COMPLAINTS FILED WITH THE
FEDERAL ELECTION COMMISSION**

Complaints filed with the Federal Election Commission shall be referred to the Enforcement Division of the Office of the General Counsel, where they are assigned a MUR (Matter Under Review) number and forwarded to Complaints Examination & Legal Administration ("CELA") for processing. Within five days of receipt of the complaint, the Commission shall notify all respondents referenced in the complaint, in writing, that the complaint has been filed, and shall include with such notification a copy of the complaint. Simultaneously, the complainant shall be notified that the complaint has been received. The respondents shall then have 15 days to demonstrate, in writing, that no action should be taken against them in response to the complaint. If additional time is needed in which to respond to the complaint, the respondents may request an extension of time. The request must be in writing and demonstrate good cause as to why an extension should be granted. Please be advised that not all requests are granted.

After the response period has elapsed, cases are prioritized and maintained in CELA. Cases warranting the use of Commission resources are assigned as staff becomes available. Cases not warranting the use of Commission resources are dismissed.

If a case is assigned to a staff person, the Office of the General Counsel shall report to the Commission, making recommendations based upon a preliminary legal and factual analysis of the complaint and any submission made by the respondent. The report may recommend that the Commission: (a) find reason to believe that the complaint sets forth a possible violation of the Federal Election Campaign Act of 1971, as amended, (hereinafter the "Act"); or (b) find no reason to believe that the complaint sets forth a possible violation of the Act and, accordingly, close the file.

If, by an affirmative vote of four Commissioners, the Commission determines that there is reason to believe that a respondent has committed or is about to commit a violation of the Act, the Office of the General Counsel shall open an investigation into the matter. During the investigation, the Commission has the power to subpoena documents, to subpoena individuals to appear for deposition, and to order written answers to interrogatories. A respondent may be contacted more than once by the Commission during this phase.

If during this period of investigation, a respondent indicates a desire to enter into conciliation, the Office of the General Counsel may recommend that the Commission enter into conciliation prior to a finding of probable cause to believe that a violation has been committed. Conciliation is an attempt to correct or prevent a violation of the Act by informal methods of conference and persuasion. Most often, the result of conciliation is an agreement signed by the Commission and the respondent. The Conciliation Agreement must be adopted by four votes of

the Commission in order to become final. After signature by the Commission and the respondent, the Conciliation Agreement is made public within 30 days of closing of the entire file.

If the investigation warrants, and no conciliation agreement has been entered into prior to a probable cause to believe finding, the General Counsel must notify the respondent of his/her intent to recommend that the Commission proceed to a vote on probable cause to believe that a violation of the Act has been committed or is about to be committed. The General Counsel shall send the respondent a brief setting forth his/her position on the legal and factual issues of the case. A response brief stating respondent's position on the issues may be submitted within 15 days of receipt of the General Counsel's Brief. Both briefs are then filed with the Commission Secretary and considered by the Commission. Thereafter, if the Commission determines, by an affirmative vote of four Commissioners, that there is probable cause to believe that a violation of the Act has been committed or is about to be committed, the Commission must conciliate with the respondent for a period of at least 30 days, but not more than 90 days. If the Commission is unable to correct or prevent any violation through conciliation, the Office of the General Counsel may recommend that the Commission file a civil suit to enforce the Act against the respondent. Therefore, the Commission may, upon the affirmative vote of four Commissioners, institute civil action for relief in the United States District Court.
