Dear FEC Commissioners,

I am filing this complaint against candidate Doyle Canning, now running in the Oregon Congressional District 4 primary, and her campaign committee.

It is my information and belief that she received at least one contribution in violation of the law, specifically 52 USC 30121: Contributions and donations by foreign nationals. I certify this complaint is being made with my awareness of Title 18, § 1001.

When reviewing her second quarter, 2019, financial filing, page 35, submitted on 7-15-19, I discovered she had reported a \$2,600 contribution from Carlos A. Joly on June 13, 2019, Transaction ID : IDTA44 . On the contribution form he claimed to be a resident of Burlington, Vermont and gave his address as that of the Courtyard Marriott hotel. He further claimed he was not employed. Both those statements appear to be false. I called the hotel and he was not registered there.

In fact, since 1998, he has been a tenured professor at the University of Campinas, in Sao Paulo state, Brazil. He also teaches at Cambridge University in Great Britain. I have included on-line bios below.

Although I believed he may have studied for and graduated with a Master's Degree from Harvard University, that was over a decade ago. He has been a professor in Brazil for 22 years. If has ever had Green Card status, rather than just a student visa, he should have filed form I-407 in order to surrender that status.

Since he does not appear to be a permanent, Green Card holding resident of the U.S., he is not eligible to make any contribution in a federal election. Per my search of FEC records, that seems to have been the only federal contribution he has ever made to any candidate. Per the National Institute on Money in Politics, [www, followthemoney.org](http://www.followthemoney.org) he has also never made a reportable contribution to any state or municipal candidate.

Under penalty of perjury, I believe that the assertions above are true.


Carlos Alfredo Joly graduated in Biological Sciences from the University of São

Paulo/USP (1976), obtained his MSc in Plant Biology at the State University of Campinas/UNICAMP (1979) and his PhD in Botany at the Univ. St. Andrews/UK (1982). Since 1998 he is a full professor in Plant Ecology at the Department of Plant Biology, Biology Institute, State University of Campinas/UNICAMP, teaching both graduate and undergraduate courses. From 2013 to 2018 he was member of the IPBES Multidisciplinary Expert Panel/MEP, being involved in various assessments and with the Capacity Building Task Force. Currently he is the Chair of the BIOTA/FAPESP Program, Co-Chair of the Brazilian Platform on Biodiversity and Ecosystem Services/BPBES, Member of the Scientific Advisory Committee of the Inter-American Institute for Global Change Research/IAI and fellow of the Brazilian Academy of Science.


